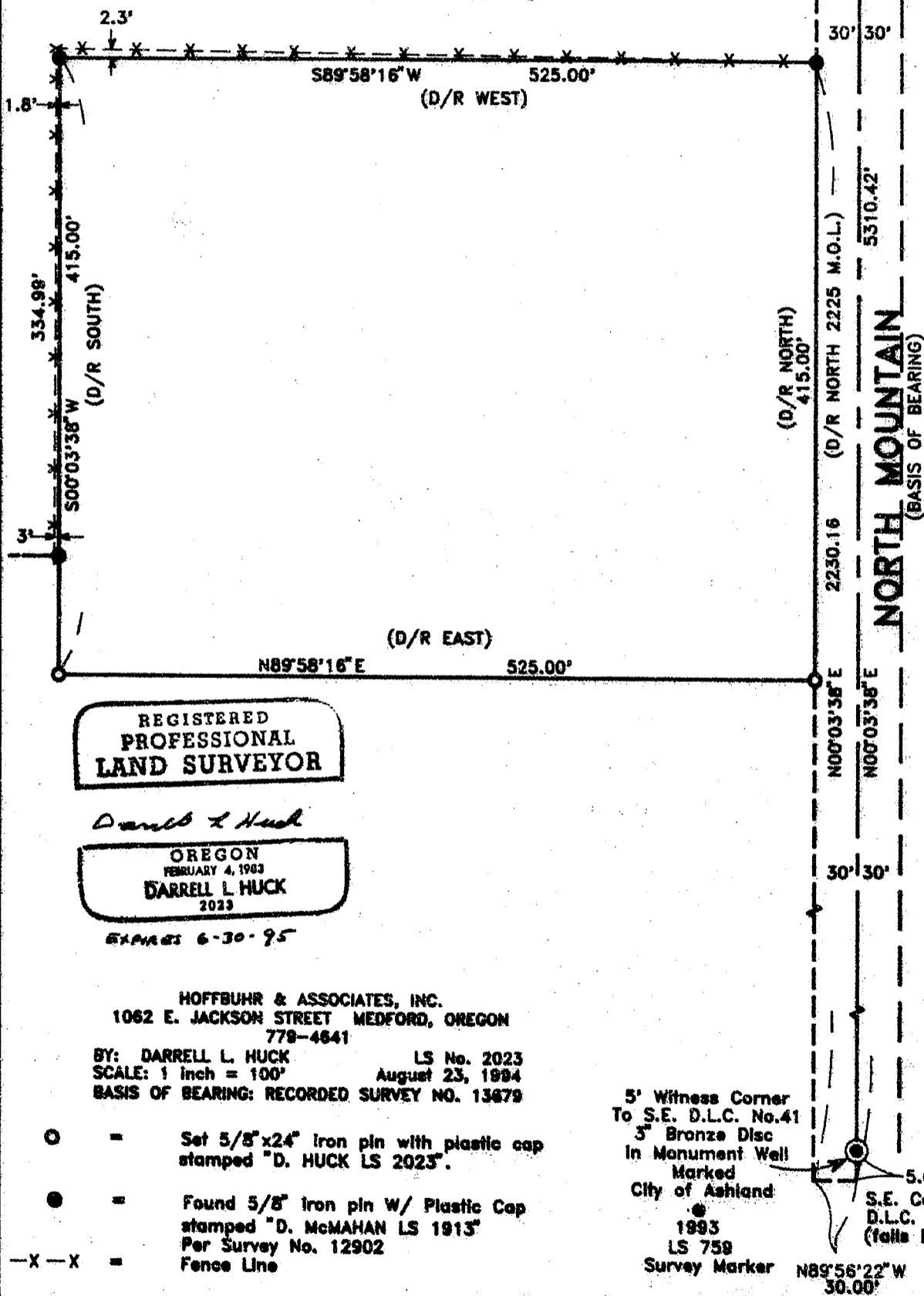

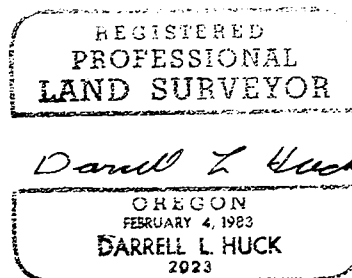
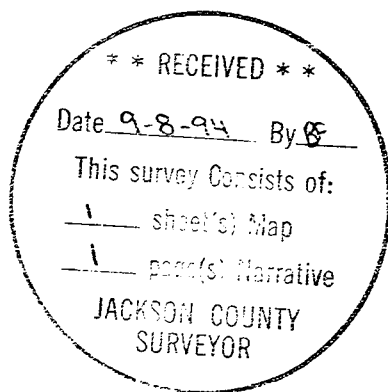
Location: Northeast one-quarter (1/4) of Section 4, Township
