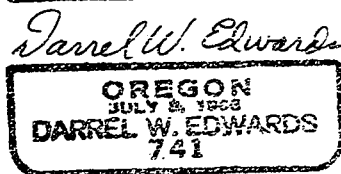
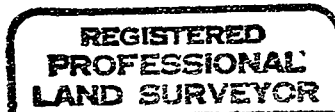
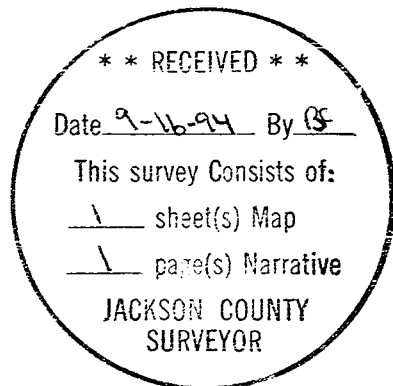
PURPOSE: Property line adjustment between Tax Lots 1800
