

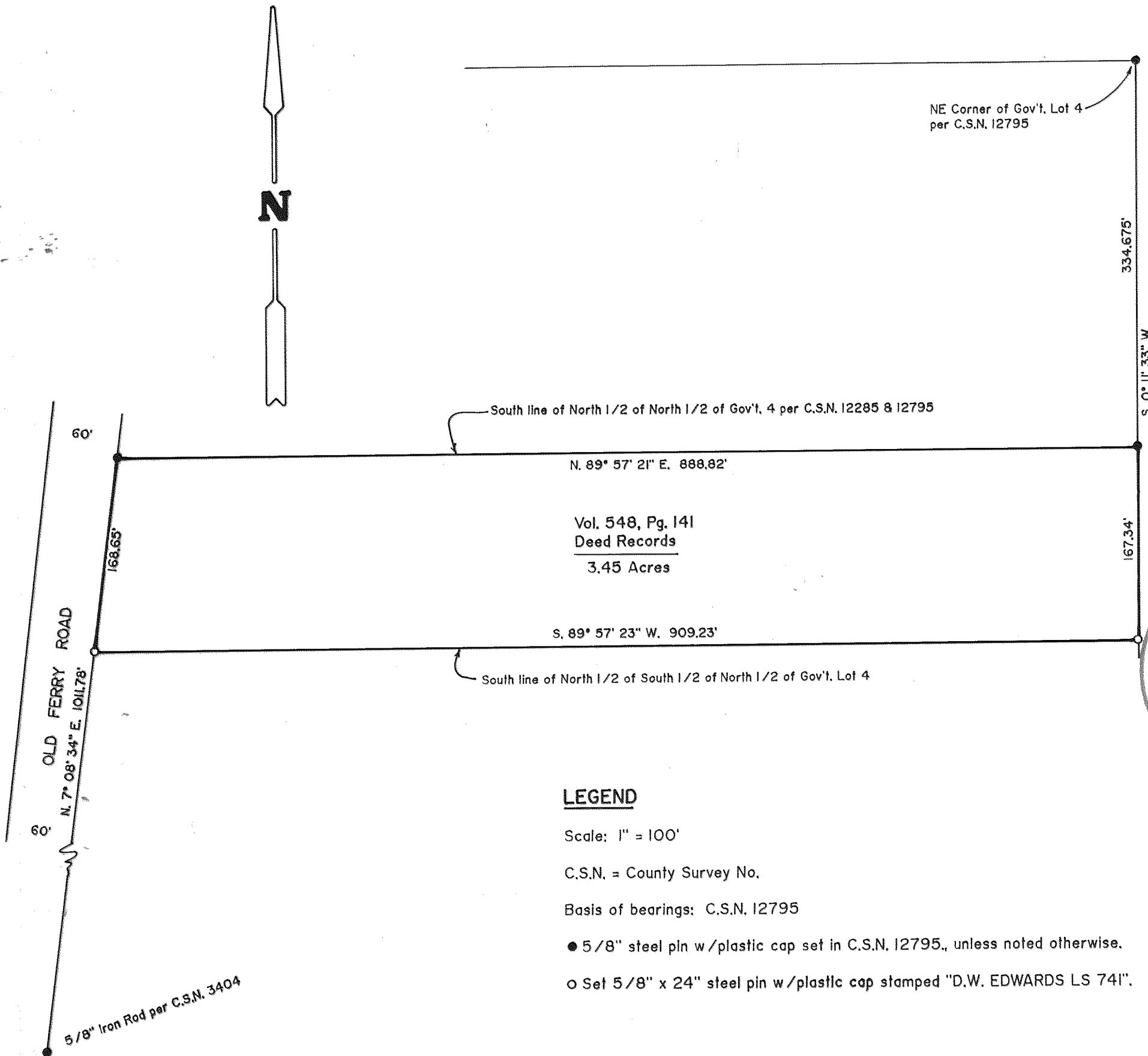

Jackson County, Oregon.

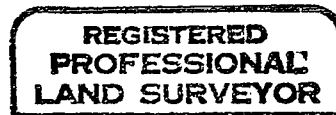
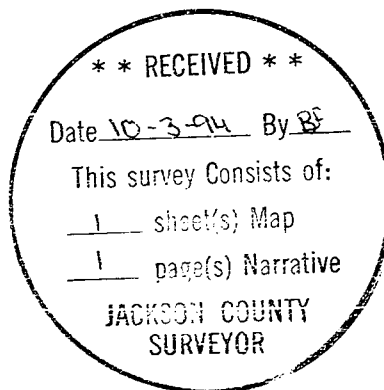
PURPOSE: To survey and mark the outside boundaries of a

SURVEY.

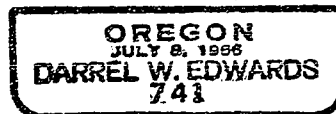
