

SURVEY NARRATIVE TO COMPLY WITH CHAPTER 209, PARAGRAPH 250, OREGON REVISED STATUTES

In Lots 7, 8 and 9 of the COOKSEY ADDITION to Central Point and the NE 1/4 of Section 10, T. 37 S., R. 2 W., W.M., Jackson County,

Oregon.

PURPOSE:

To locate and monument the boundaries of that tract described in Vol. 384, Pg. 2, Deed Records, as shown on the accompanying map.

PROCEDURE:

Utilizing for control the found monuments as shown, as well as data from the plat of COOKSEY ADDITION, computed the locations of the boundaries as shown. My measurement along the center line of Haskell Street from Pine Street to the D.L.C. line would generate about a 9 foot difference from the COOKSEY ADD. plat, which seems a bit much to prorate through the lots. Previous surveys show holding to plat record from Pine Street and I continue this procedure holding to monuments set on

S.N. 9672. Monuments set on this survey consist of 5/8" x 24" steel pins with red plastic caps
