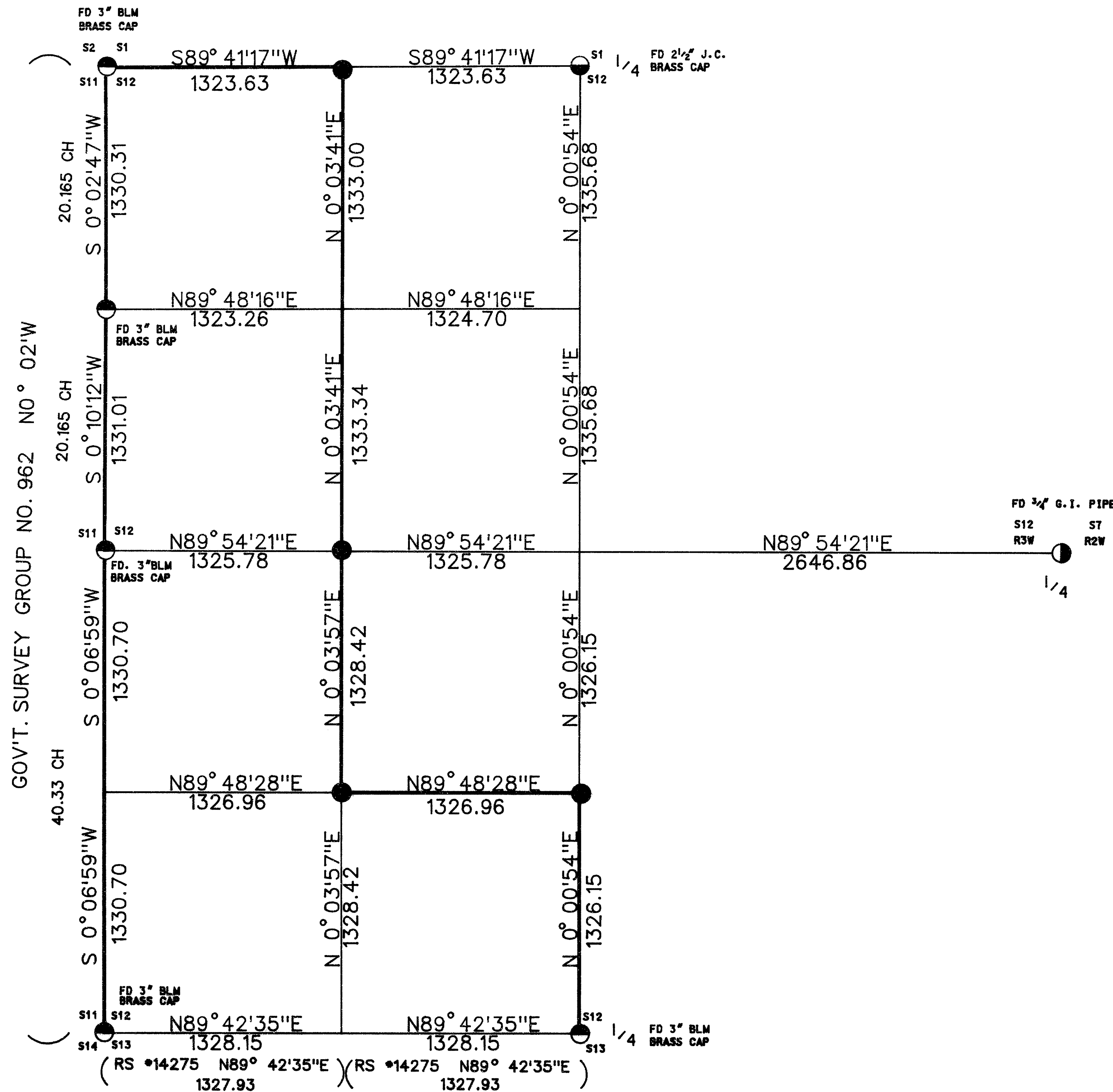
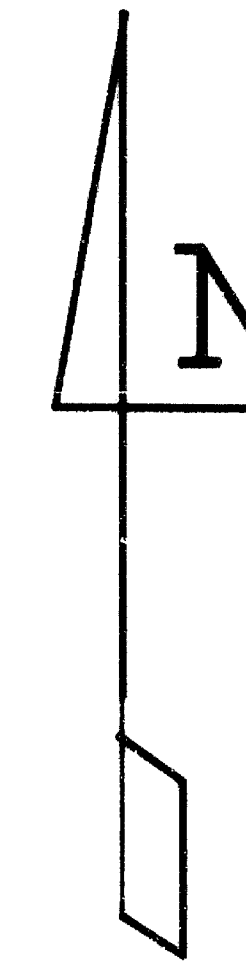


MAP OF SURVEY LOCATED IN W1/2 OF S12 T35S R3W W.M.

PURPOSE: TO MARK AND POST THE BOUNDARIES OF MEDITE CORPORATION LAND IN THE NORTHWEST AND THE SOUTHWEST QUARTERS OF SAID SECTION 12, AS SHOWN ON THE PLAT TO ACCOMPANY THIS NARRATIVE.

PROCEDURE: A SEARCH OF RECORDS AT THE JACKSON COUNTY SURVEYORS OFFICE REVEALED THAT THE SECTION AND QUARTER-SECTION CORNERS NEEDED FOR CONTROL OF THIS SURVEY HAD BEEN RE-ESTABLISHED FROM ORIGINAL EVIDENCE OR PROPORTIONATE MEASUREMENTS.

A TRAVERSE WAS RUN TYING TO THE CORNERS NEEDED FOR CONTROL OF THIS SURVEY. SUBDIVISION OF THE SECTION WAS CALCULATED, LINES TO BE MARKED AND POSTED WERE TRAVERSED, TYING TO THE CONTROL TRAVERSE. CORNERS WERE SET, AND LINES WERE MARKED AS SHOWN ON THE PLAT TO ACCOMPANY THIS NARRATIVE.
