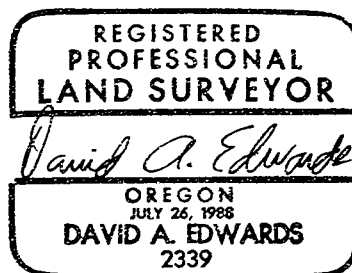
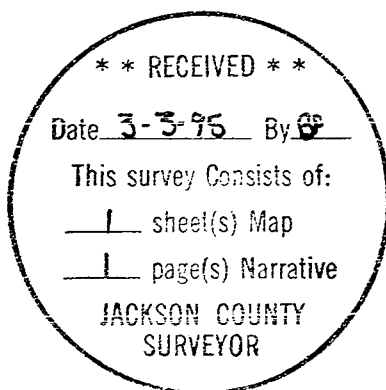
**PURPOSE:** To locate and monument a portion of the  
boundaries of tract described in Document  
Number 78-10360, Official Records, as shown on  
the accompanying map.

**PROCEDURE:** Utilizing existing control points and data  
established by this office during the execution  
of Survey Number 12353, as well as data from  
the above noted document, computed the  
boundaries of the subject property as shown.  
The apparent intent of deed found in Volume  
378, Page 259 was to describe the North half of
