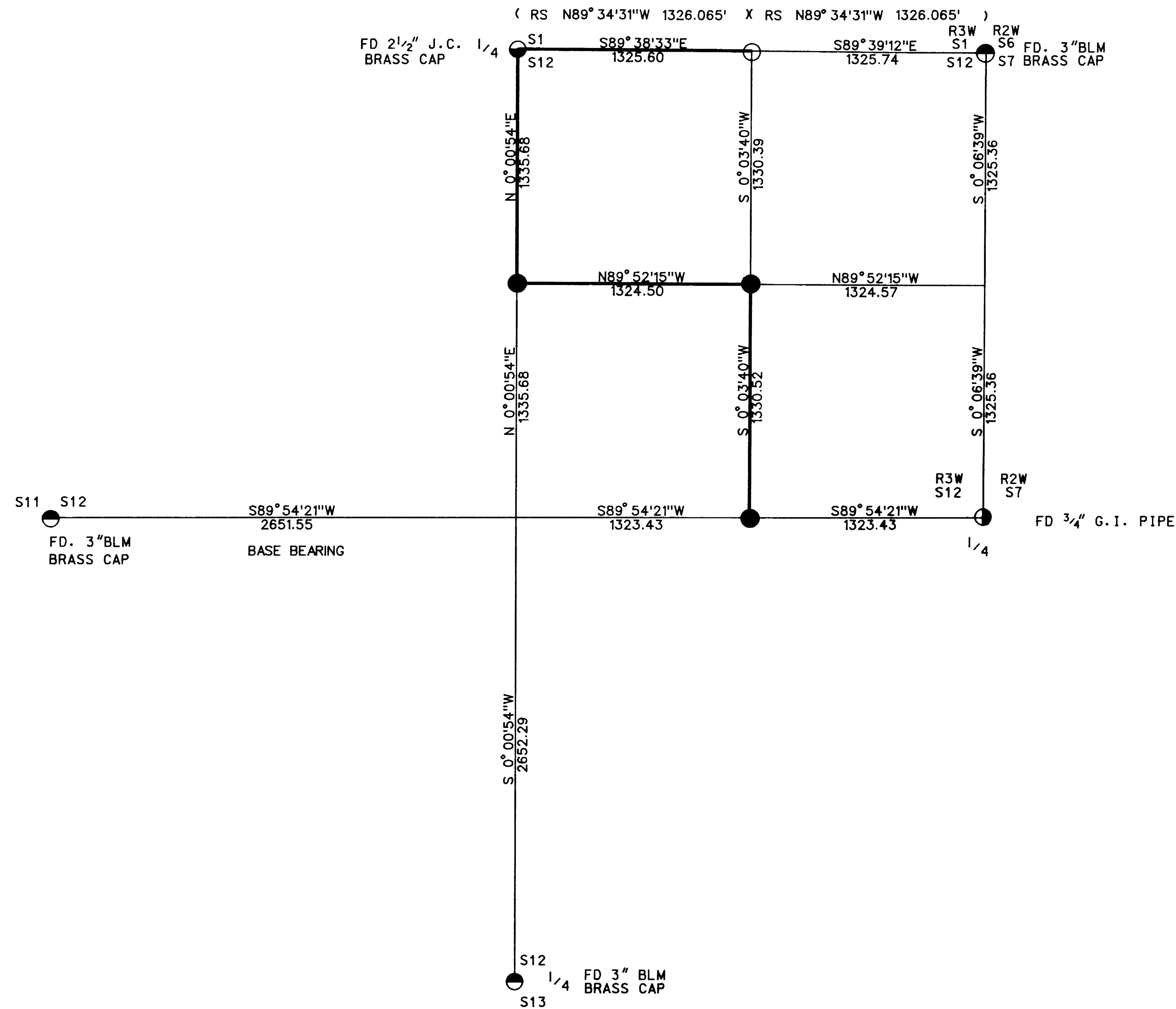

BASIS OF BEARING: SURVEY NUMBER 14332

PURPOSE: TO SET THE CENTER NORTH, NORTH EAST, AND CENTER EAST ONE-SIXTEENTH CORNERS OF SAID SECTION 12. TO MARK THE LINES AS SHOWN ON THE PLAT TO ACCOMPANY THIS NARRATIVE.

PROCEDURE: A SEARCH OF RECORDS AT THE JACKSON COUNTY SURVEYORS OFFICE REVEALED THAT THE SECTION AND QUARTER-SECTION CORNERS NEEDED FOR CONTROL OF THIS SURVEY HAD BEEN RE-ESTABLISHED FROM ORIGINAL EVIDENCE OR PROPORTIONATE MEASUREMENTS.

A TRAVERSE WAS RUN BEGINNING AT THE EAST 1/4 CORNER OF SECTION 12 UTILIZING A TRAVERSE RUN ON SURVEY #14332, THENCE RUNNING TO THE NORTH EAST CORNER OF SECTION 12, THENCE RUNNING TO THE NORTH 1/4 CORNER OF SECTION 12 TYING TO THE TRAVERSE RUN ON SURVEY #14332. SUBDIVISION OF THE NORTH EAST 1/4 OF SECTION 12 WAS CALCULATED. LINES TO BE MARKED WERE TRAVERSED, TYING TO THE CONTROL TRAVERSE. CORNERS WERE SET, AND LINES WERE MARKED AS SHOWN ON THE PLAT TO ACCOMPANY THIS NARRATIVE.

ALL MEASUREMENTS TO BEARING TREES ARE TO THE CENTER OF TREE AT THE BASE UNLESS OTHERWISE STATED. ALL BEARING TREES HAVE A BRASS WASHER STAMPED LS 1086 ATTACHED TO LOWER FACE.
