





Northeasterly corner of tract described Instrument No. 94-24410 O.R. was located at deed record South (1729.00') and East (1330.90') from the NE corner of Section 33. Another possibility for locating said Northeasterly corner was to run Southerly along the East boundary of Westhalf of the NE % of Section 33,1729.0 feet. After analyzing said deed and the deeds of adjacent properties it became obvious that the original intent was to locate said corner as shown, record distance South and East from the NE corner of Section 33. The Northerly boundary of tract was located by running record bearing and distance (N 65° 30' W, 578.00') to and angle point then record bearing (S 73° \emptyset 7' \emptyset) to intersect the Easterly right-of-way line of Derby Road. The boundaries of tract described in Inst. No. 94-40792 O.R. were located from monuments set on Filed Survey No. 14017.

The boundary between Parcel Nos. 1 and 2 was located per the clients direction and the county approval.

PROCEDURE:

Utilizing EDM equipment ran a random

traverse tieing monuments shown on the accompanying map, the physical center of Derby Road, power lines, well and the physical center of driveways shown as "Road Easement".

The Derby Road right-of-way lines were located 30' from the physical center of said road as directed by Jackson County Public Works.

The boundaries of the West-half of the NE ¼ of Section 33 were located from surveys of record as shown.

Most Easterly corner of tract described Instrument No. 85-03515 O.R. was located at the intersection of the East-West centerline of Section 33 and the Westerly right-of-way line of Derby Road and the Most Westerly corner of said tract was located deed record distance (972.71 feet) West along said section centerline from the Most Easterly corner. The Most Northerly corner of said tract was located running record bearing Northeasterly (N 33° 52' E) from said Most Westerly corner to intersect the Westerly right-of-way line of said Derby Road.
