LOCATION:

Township 40 South, Range 3 West, NW 1/4 Section 17, W.M., Jackson County, Oregon.

PURPOSE:

The purpose of this survey is to establish the adjusted property boundaries as outlined in Jackson County Lot Line Adjustment (94-70-LLA). These adjusted property boundaries will resolve a well encroachment by Gary L. Fossen on Government Land.

HISTORY OF SURVEYS:

This current survey is based on Jackson County Record Survey No. 11069 dated November 20, 1987. A detailed history of surveys can be found in that survey.

PROCEDURE:

This survey began at the North 1/16 corner for Sections 17 and 18. Utilizing the existing control from R.S. 11069, a closed traverse was run around the new tract (U.S. to Gary Fossen). Property corners were set as shown on the attached Map of Survey.

That portion of the South line of the Northwest 1/4 of the Northwest 1/4 of Section 17, previously marked and posted as National Forest land that will now become private, was de-posted as follows: Aluminum posts and National Forest Boundary signs were removed. Blazed trees along the old property boundary were painted with black paint. Bearing tree tags and signs were left on the trees.

The new boundary between private and Forest Service was marked and posted with six foot aluminum posts with National Forest Boundary signs attached. Trees along the line were blazed and painted with red timber marking paint.
