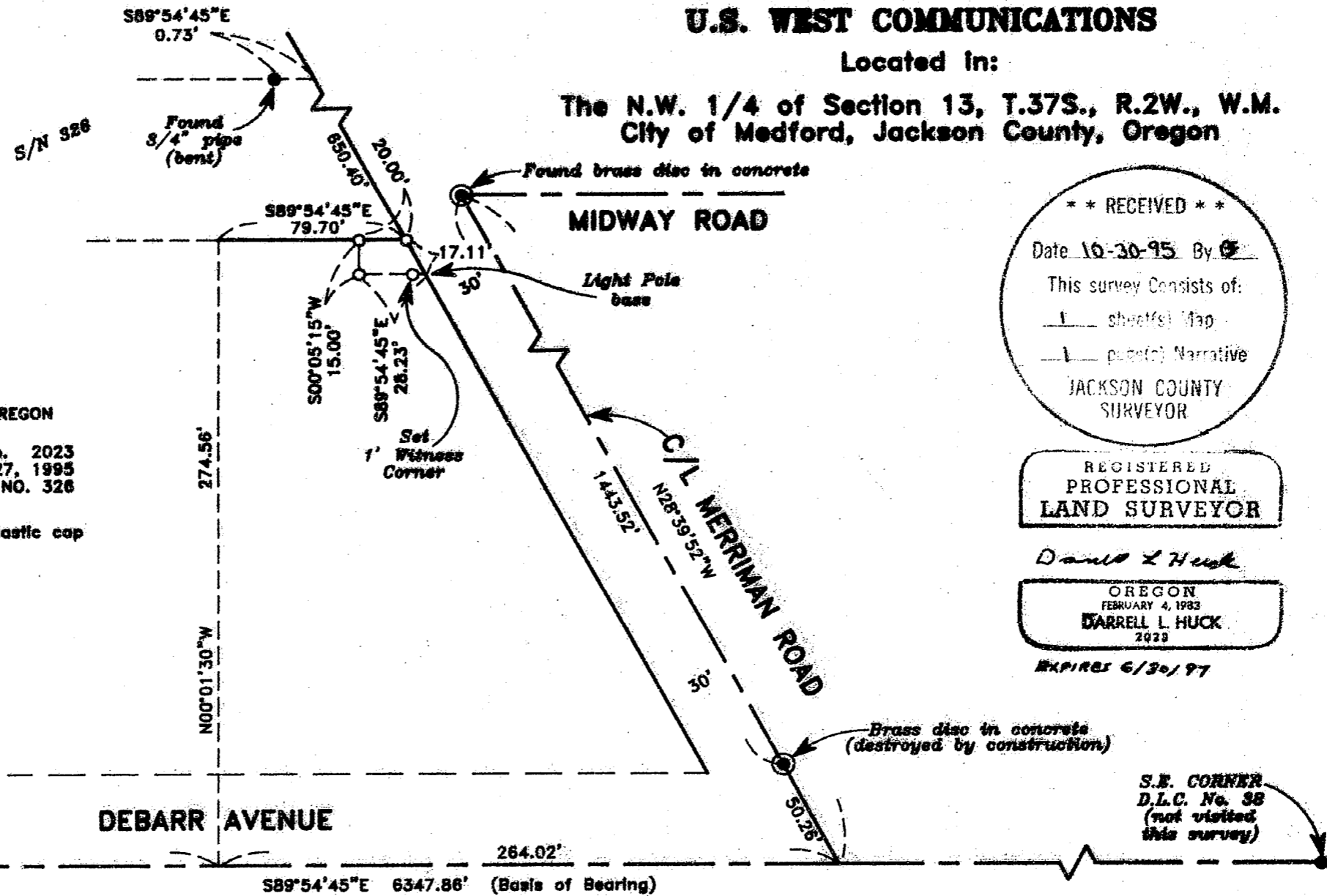

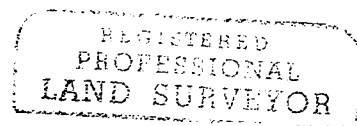
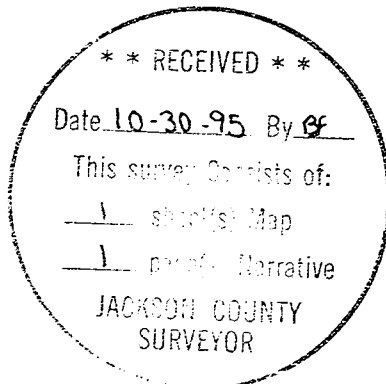
Location: Northwest one-quarter (1/4) of Section 13 in Town-
ship 37 South, Range 2 West, Willamette Meridian,
City of Medford, Jackson County, Oregon

Purpose: To survey and monument an easement location as
directed by client

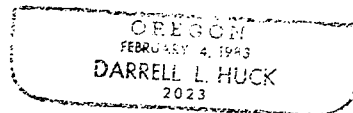
Procedure: Control established by this office to accomplish
Survey No. 13644 was also used for this survey.
The location of the North line of Tax Lot 3500 was
held at deed distance from the Donation Land Claim
line as measured between the Southwest corner of
Donation Land Claim No. 59 and the Southeast corner
of Donation Land Claim No. 38. The bearing of the
North line was held parallel to the Donation Land
Claim line, which follows the procedure as set
forth by Survey No. 326. The easement corners were
computed and monuments were set as shown on the
attached map.
