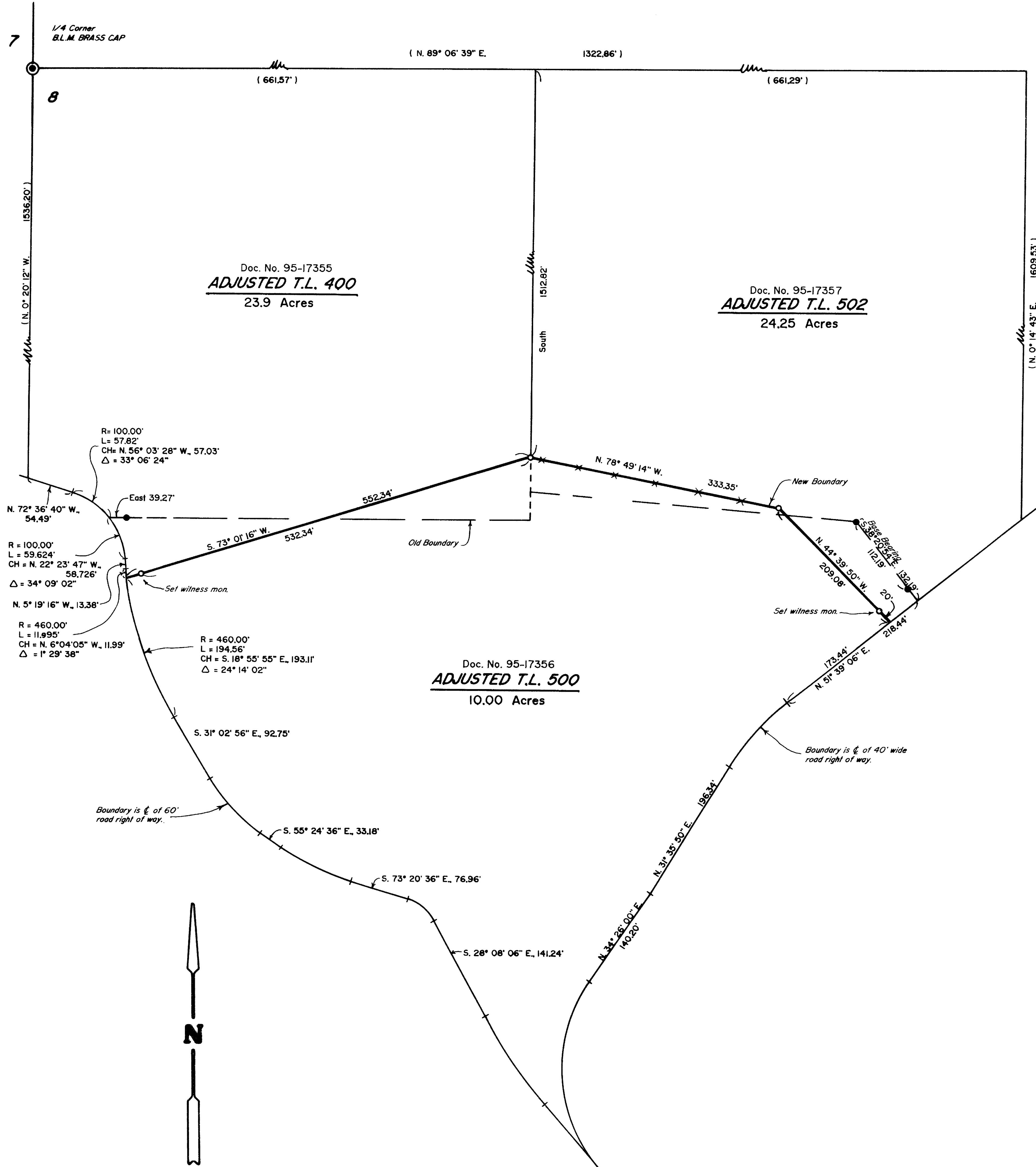


MAP OF SURVEY

PROPERTY LINE ADJUSTMENT

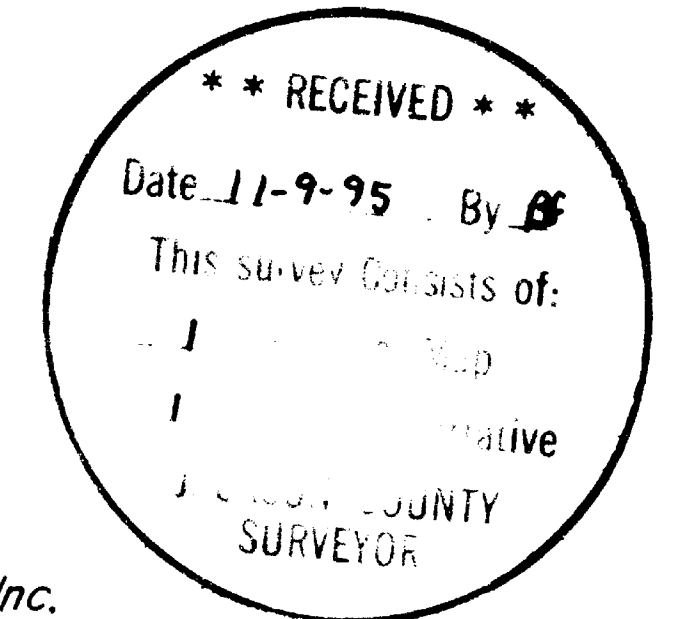

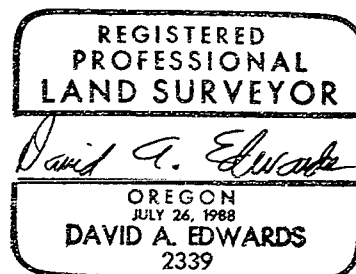
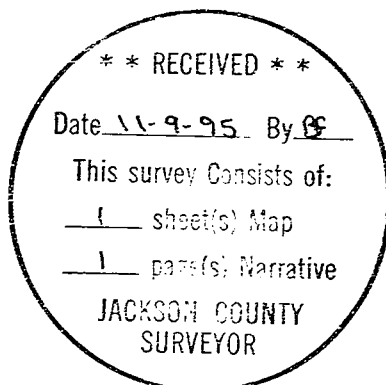
PURPOSE: PROPERTY LINE ADJUSTMENT; County Planning Dept.
