
MAP OF SURVEY

(14) CENTER WEST 1/16 CORNER SECTION 30 set a 5/8 by 30 inch iron pin monument with yellow plastic cap marked "FARBER PLS 2189", from which bears: an 8 inch Douglas Fir S38°W, 6.0 feet an 11 inch Douglas Fir S56 3/4°E, 3.0 feet all bearing trees are scribed "CW 1/16 S 30 B T" with U.S.D.A. Forest Service bearing tree tags (series 54-3) affixed at chest height, facing monument and marked LS 2189. All B.T.'s measured to the center of the tree at ground level.

(15) CORNER No.4 GOLD NOTE No.2 LODE found 8 inch by 24 inch stone, exposed 7 inches with chisel marks in a rock collar and accessories per

(16) CORNER No.3 GOLD NOTE EXTENSION LODE found 6 inch by 10 inch stone, exposed 6 inches in a rock collar with chisel marks and accessories per Mineral Survey No. 923.



- (9) SOUTH 1/16 CORNER SECTION 25 AND 30 found 3 1/2 inch standard B.L.M. brass cap, exposed 0.3 feet, with accessories per B.L.M. corner notes.
- (10) WEST QUARTER CORNER SECTION 30 found 3 1/2 inch standard brass cap, with corner accessories per B.L.M. corner notes.
- (11) NORTH 1/16 CORNER SECTION 25 AND 30 set a 5/8 by 30 inch iron pin monument with yellow plastic cap marked "FARBER PLS 2189", from which bears: a 7 inch Douglas Fir N82 3/4°W, 9.6 feet a 14 inch Douglas Fir N79°E, 42.7 feet all bearing trees are scribed "N 1/16 S 30 B T" with U.S.D.A. Forest Service bearing tree tags (series 54-3) affixed at chest height, facing monument and marked LS 2189. All B.T.'s measured to center of the tree at ground level.
- (12) NORTHWEST 1/16 CORNER SECTION 30
 set a 5/8 by 30 inch iron pin monument with yellow
 plastic cap marked "FARBER PLS 2189", from which bears:
 a 6 inch Douglas Fir N27°W, 18.0 feet
 a 7 inch Sugar Pine S72 1/4°E, 23.5 feet
 all bearing trees are scribed "NW 1/16 S 30 B T" with
 U.S.D.A. Forest Service bearing tree tags (series 54-3)
 affixed at chest height, facing monument and marked LS
 2189. All B.T.'s measured to the center of the tree at
 ground level.
- (13) CORNER No.3 GOLD NOTE No.2 LODE found 12 inch by 14 inch stone, exposed 6 inches with chisel marks in a mound of stone and fir snag B.T. with scribbing visible per Mineral Survey No. 923, the Yew

(1) NORTHWEST CORNER SECTION 30 found 3 1/2 inch standard B.L.M. brass cap, exposed 0.40 feet in rock collar, with accessories per B.L.M. corner notes, the Grand Fir and the fir snag were not found.

(2) NORTH QUARTER CORNER SECTION 30 found 3 1/2 inch standard B.L.M. brass cap, exposed 0.4 feet in rock collar, with accessories per B.L.M. corner notes, the root hole and the fir snag were not found.

(3) NORTHEAST CORNER SECTION 30 found 3 1/2 inch standard B.L.M. brass cap, exposed 0.5 feet in rock collar, with accessories per B.L.M. corner notes, the original Cedar was not found.

(4) EAST QUARTER CORNER SECTION 30 found a 5/8 inch iron pin monument with yellow plastic cap marked "ARTMAN RLS 2268", exposed 0.25 feet, with accessories per S/N 12185.

(5) CENTER QUARTER CORNER SECTION 30
set a 5/8 by 30 inch iron pin monument with yellow
plastic cap marked "FARBER PLS 2189", from which bears:

Purpose:

To survey and monument and mark the property

lines as shown on the accompanying Plat.

Procedure:

Utilizing Trimble ST and SSi Global Positioning receivers and a Nikon AL-10 total station and Sokkia SDR33 data collector I tie the controlling monuments and subdivide the section as shown on the accompanying Plat. The Lot 1 and the northeast quarter of the northwest quarter of Section 30 was patented in 1909 to William H. Fisher as recorded in Volume 64, Page 347 of the Deed Records of Jackson County, Oregon. The west half of the northeast quarter, the southeast quarter of the northwest quarter and the northwest quarter of the southeast quarter of said Section 30 was patented in 1909 to James Brackett as recorded in Volume 64, Page 428 of said Deed Records. The Lot 4, the southeast quarter of the southwest quarter and the southwest quarter of the southeast quarter of said Section 30 was patented to William H. Sprangle in 1909 as recorded in Volume 54, Page 628 of said Deed Records. Notice of Lode Claim Location for Gold Note No.2 Minning Claim was recorded on the 1st of June, 1948 in Volume 49, Page 47 of the Minning Records of Jackson County, Oregon and the Gold Note Extension location certificate was filed on the 27th of April, 1936 in Volume 33, Page 624
