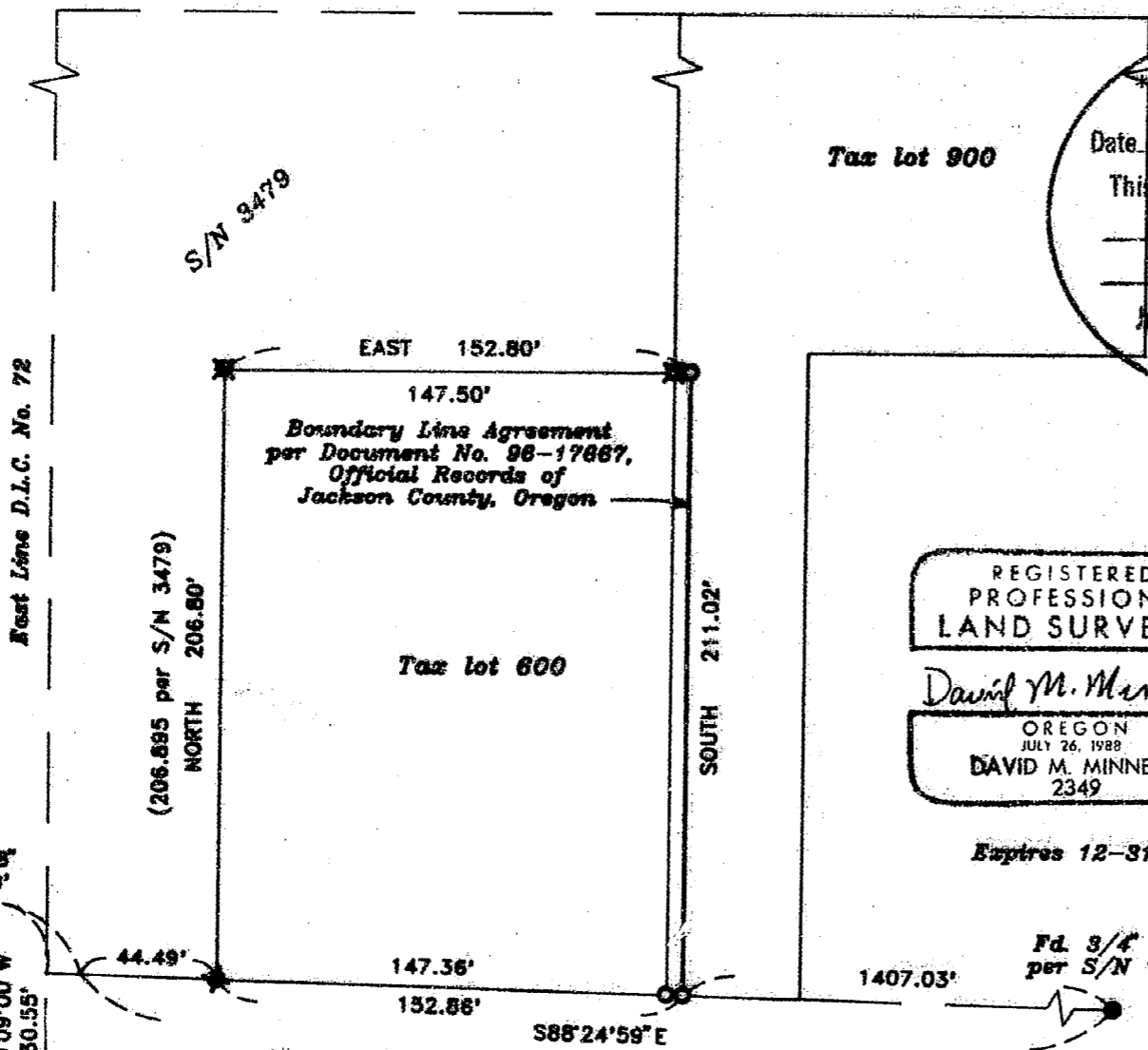

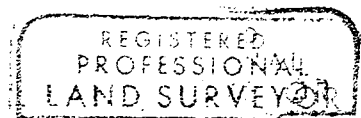
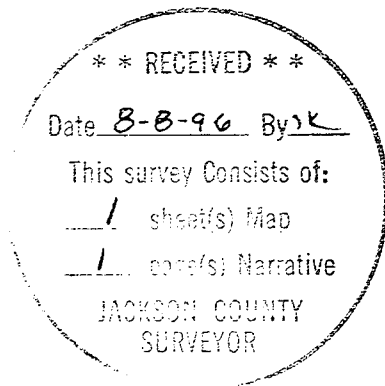

Purpose: To change client's name & refile Survey No. 14400

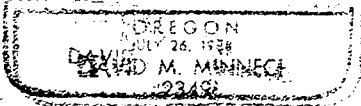
Procedure: Utilizing found monumentation from Surveys No. 3479
