BEGINNING AT the Initial Point, being a 5/8 by 30 inch iron pin, monumenting the most westerly corner of Lot 211 of Forest Glen, Phase VI as recorded in Volume 20, Page 61 of the Plat records of Jackson County, Oregon, located in the northeast quarter of Section 11, Township 37 South, Range 2 West of the Willamette Meridian, City of Central Point, Jackson County, Oregon; thence North 47°55'58" East, along the northwesterly line of said Lot 211, 139.99 feet, to a 5/8 inch iron pin monumenting the most northerly corner of said Lot 211; thence South 42°04'03" East, along the northeasterly line of said Lot 211 and its southeasterly extension, 136.00 feet, to a 5/8 inch iron pin monumenting the most easterly corner of Lot 210 of said Forest Glen, Phase VI; thence South 47°55'58" West, along the southeasterly line of said Lot 210, 139.99 feet, to a 5/8 inch iron pin monumenting the most southerly corner of said Lot 210; thence North 42°04'06" West, along the southwesterly line of said Lot 210 and its northwesterly extension, 136.00 feet to the Initial POINT OF BEGINNING.

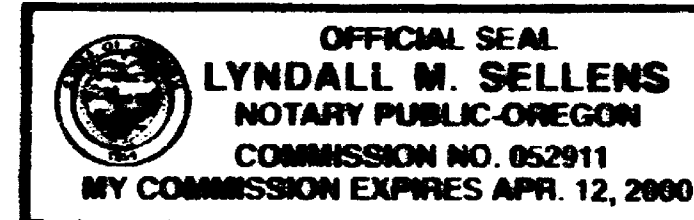

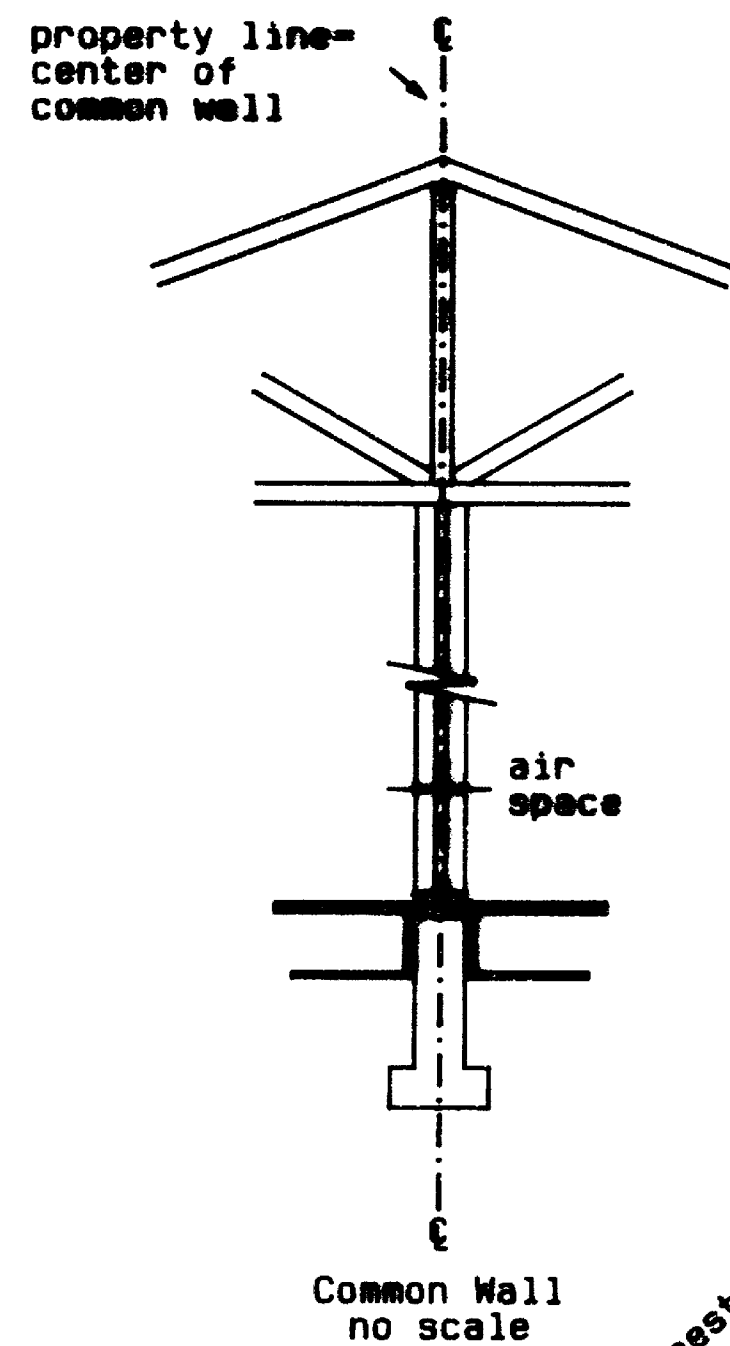

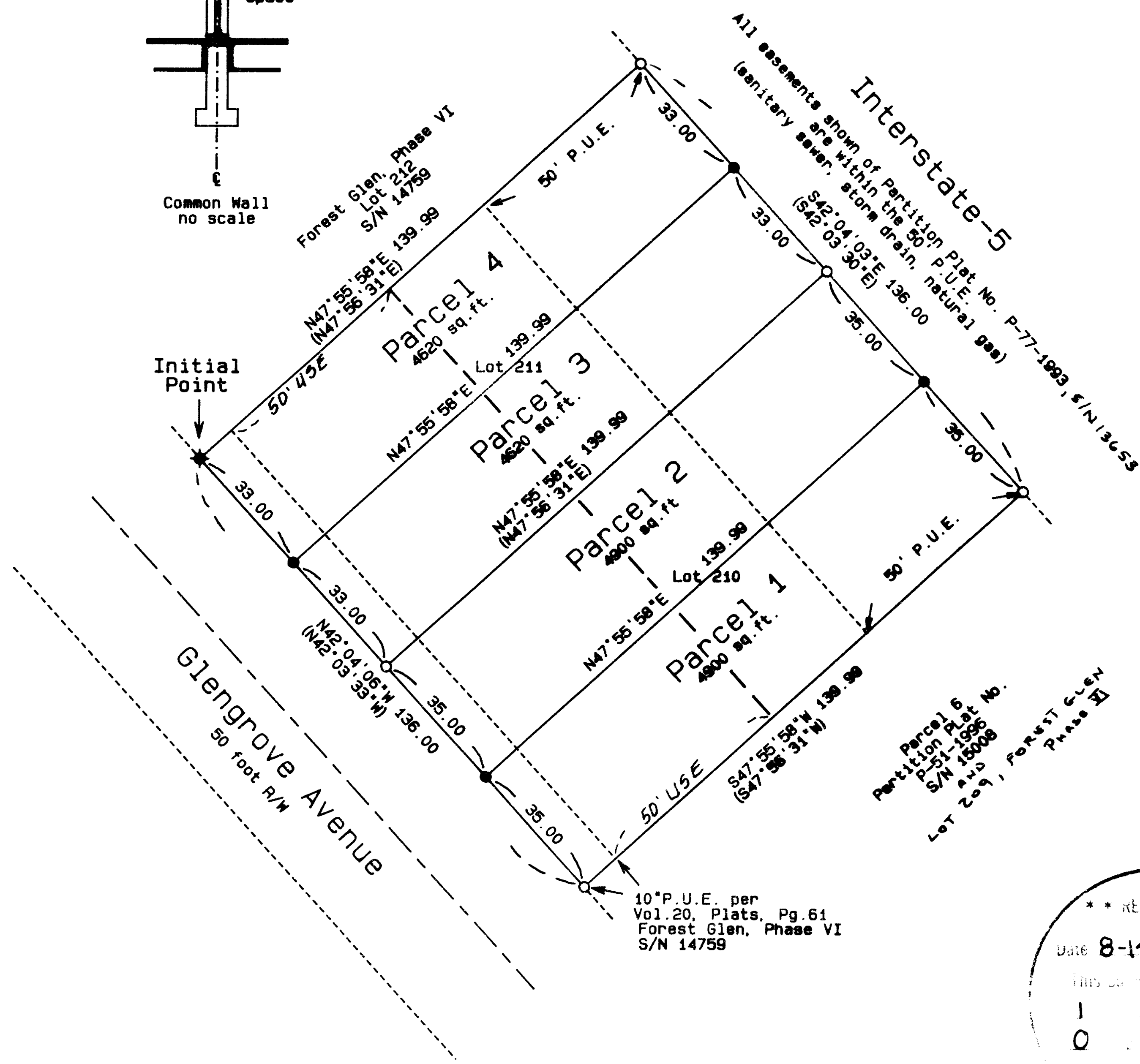
SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250
