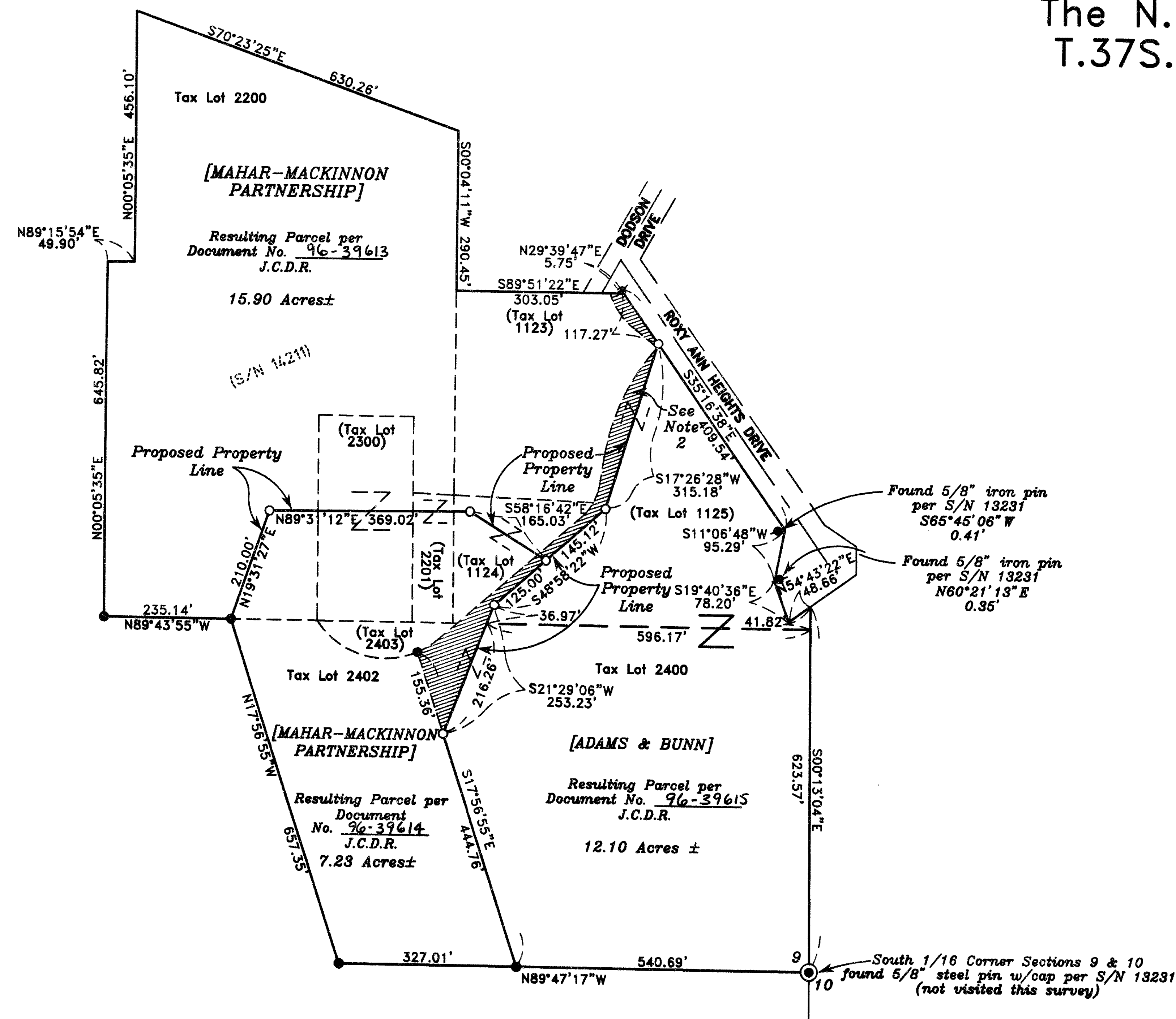


MAP OF SURVEY (Property Line Adjustment)

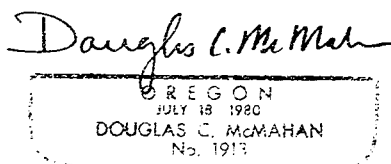
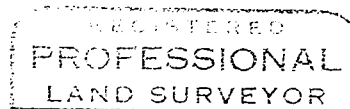
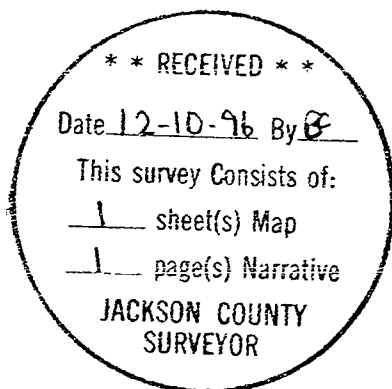
