The most Easterly boundary of the

subject tract was located at deed record distance (583.00') East from the North-South centerline of Section 24 and parallel there to. This line being the Northerly extension of the East boundary of the tract surveyed on Filed Survey No. 14884.

The North boundary of the South-half of the Southeast Quarter of Section 24 was computed from data previously compiled by this office on Filed Survey No. 14984.

At the center South one-sixteenth corner set a 1" x 36" G.I. pipe with plastic cap from which:

A 9" black oak scribed "CS 1/16-BT" bears N 9° 22' W, 28.9'

A 5" black oak scribed "CS 1/16-BT" bears N 84° 59' W, 10.3'

A fence corner (N-S-E) bears N 56° Ø5' E, 1Ø.5'
