KNOW ALL MEN BY THESE PRESENTS, that I, Lloyd M. Haines am the owner in fee simple of the lands hereon described and I do hereby make, establish and declare that this plat is a correct representation of the land as laid out, as ASHLAND CREEK CONDOMINIUMS. I hereby dedicate to the City of Ashland for public use, those areas designated as public utility easements.
