SURVEYOR'S CERTIFICATE

I, Paul D. Lewis, a Registered Professional Land Surveyor of the State of Oregon, do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law, the tract of land shown hereon and that this plat is a correct representation of said tract and that the following is an accurate description of the boundary lines:





LOCATION:

26, T37S, R1W, W.M. also a portion of Monitor Orchard Subdivision,

Jackson County, Oregon.

PURPOSE:

To survey and monument the boundary of the client tract and subdivide said tract as instructed by the client. To process the subdivision per

requirements of Jackson County Planning File 96-3-S.

PROCEDURE:

Using a Nikon NTD-4 semi total station, sections 25 & 26 were controlled and subdivided as shown. Filed Survey No. 13369 had previously subdivided section 26, locating and holding a 1" square bar for the West 1/4 corner, proportioning the North 1/4 corner and holding a found 1" pin for the center 1/4 corner. This survey and procedure were reviewed and accepted. As well, Filed Survey No. 10759 had established a center 1/4 corner for section 25, which was found out of position by this survey; probably due to unstable soil conditions; (a very common problem in this area).

The location of Cherry Lane was established using found monumentation from a 1935 County Road Survey (by Paul Rynning, County Engineer) as well as utilizing some of the record curve data. This road location survey was generated from creating document, Volume 202 Page 268 of Jackson County Records. The north-south portion of Cherry Lane was controlled by found monuments; a found 5/8" rebar and cap set by Filed Survey No. 13597 at the intersection of the west right of way line with the north line of Section 26 (STA 133+87.3); a found 5/8" iron pin on said West right of way per Filed Survey No. 2691, as well as the found 1" pipe (PI STA 108+55) at the southerly end. From this 1" pipe the road centerline was developed in a southwesterly direction through a computed point 30 feet northwesterly of the found 1 1/2" square bolt (PI STA 102+73.6). The portion of Cherry Lane running in a southeasterly direction was located by holding the found 1" pin (PI 71+65.8) on the west and developing a centerline alignment 30 feet northeasterly of the found 3/4" iron pin (PC STA 97+66.7) at the easterly end of that tangent. These two tangents were extended to a point of intersection and curves computed holding the record radius distances. Resulting computed curve parameters matched record data unusually well.
