THIS PARCEL IS INCLUDED IN TAX LOT 1100 IN THE JACKSON COUNTY ASSESSORS OFFICE. THIS PARCEL IS SHOWN AS PART OF NEW TAX LOT 900 ON THE PLAT TO ACCOMPANY THIS NARRATIVE. AT THE WRITING OF THIS NARRATIVE THIS PARCEL IN GOVERNMENT LOT 3 IS NOT BY DEED OF RECORD A PART OF TAX LOTS BEING ADJUSTED. "IT MAY BE OF INTEREST TO NOTE THAT THE RAILROAD ACQUIRED A STRIP OF LAND 50 FEET EACH SIDE OF CENTERLINE BY DEED IN 1887 (VOL. 14, PAGE 581 ) AND IN AS MUCH AS THIS WAS PATENTED LAND PRIOR TO 1887 IT IS NOT UNDERSTOOD BY THIS WRITER HOW THE SOUTHERN PACIFIC RAILROAD COMPANY IN THEIR MAP "V-15-5" CAN CONSTRUE THE CONGRESSIONAL ACT OF 1866 GRANTING 100 FEET EACH SIDE OF CENTERLINE TO APPLY. AS THIS WRITER IS NOT QUALIFIED TO STATE AN OPINION IN THIS MATTER, THE FACTS SHOULD BE PUT ON NOTICE TO PARTIES INVOLVED." THIS WRITER WOULD CONCUR WITH THE STATEMENT OF MR. BURRELL CONCERNING THESE STRIPS OF LAND. THESE LINES WERE NOT SURVEYED ON THIS SURVEY AS SAID LINES WERE NOT NEEDED TO SHOW THE NEW PROPERTY LINES.
