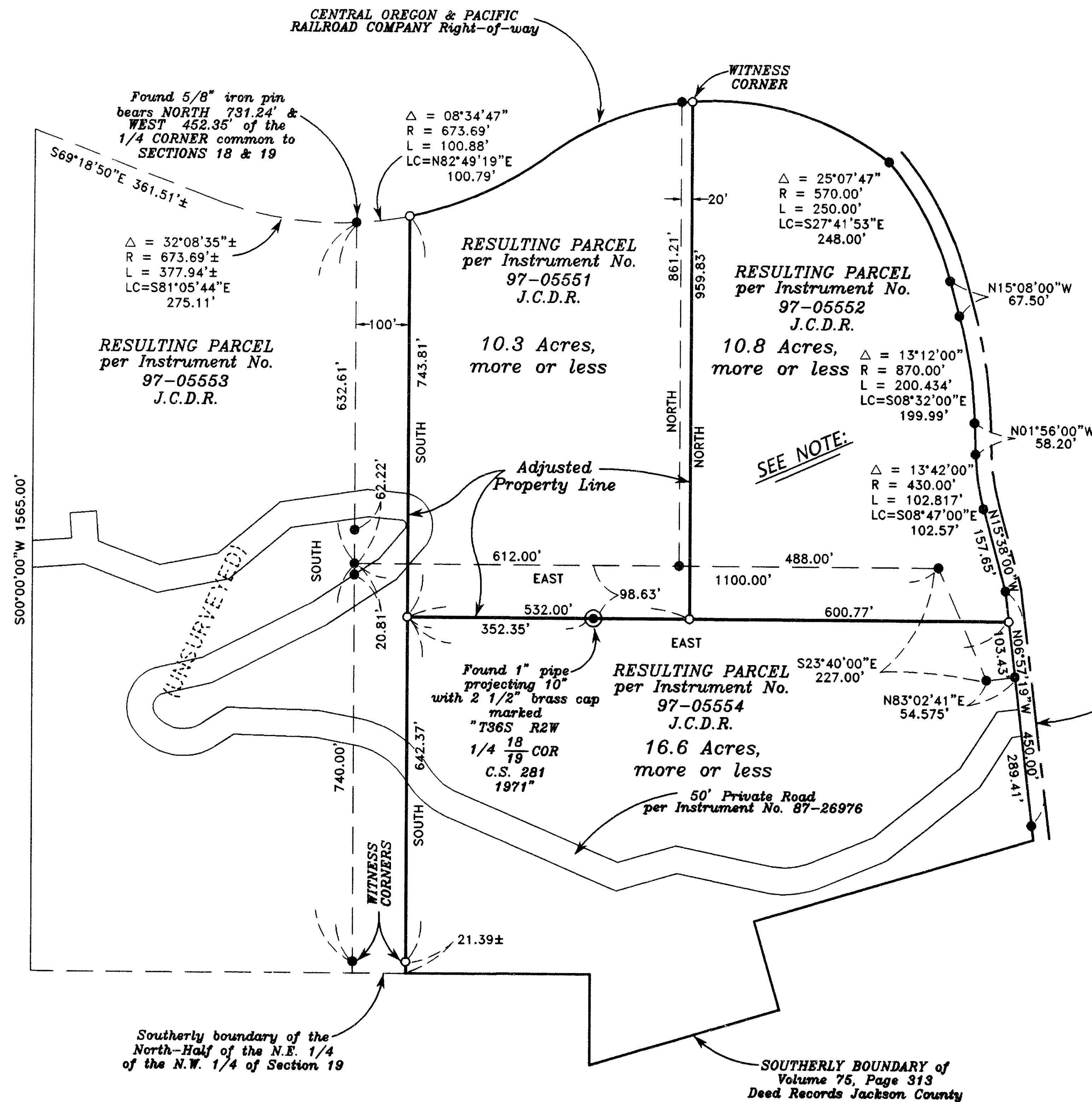


MAP OF SURVEY PROPERTY LINE ADJUSTMENT FOR JOHN P. DAY

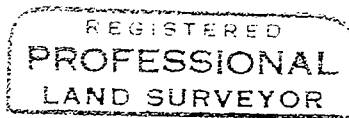
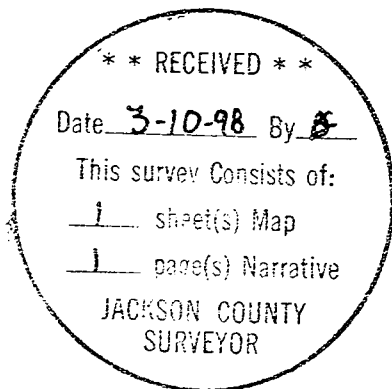

Purpose: To adjust property lines as shown on the attached Map of Survey

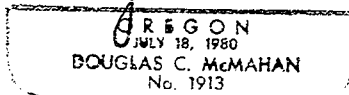
