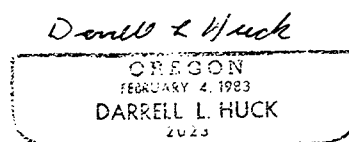
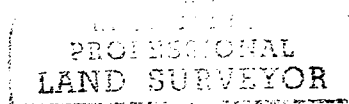
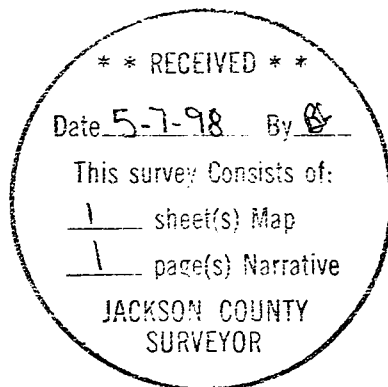
LOCATION: In Lot 31 of BELLVIEW TRACT and Parcel 2 of Partition Plat recorded April 30, 1992 as Partition Plat No. P-51-1992 of "Record of Partition Plats", in the Southeast One-Quarter (1/4) of Section 15, Township 39 South, Range 1 East, Willamette Meridian, Jackson County, Oregon

PURPOSE: To survey and monument a property line adjustment as approved by the Jackson County Planning Department

PROCEDURE: The property line to which this survey pertains has been surveyed and monumented per filed Survey Numbers 9294 and 12959. A control traverse was run tying monuments found per those surveys. The location of the new, adjusted property line was computed according to client's direction and monuments were set as shown on the attached map.
