SURVEYOR'S CERTIFICATE:

I, ROGER T. REECE, REGISTERED LAND SURVEYOR No. 864, CERTIFY THAT I AM A DULY REGISTERED PROFESSIONAL LAND SURVEYOR OF THE STATE OF OREGON AND THAT I HAVE ACCURATELY SURVEYED THE PARCEL OF LAND DESIGNATED AND REPRESENTED ON THIS PARTITION PLAT, THE BOUNDARIES BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 20, TOWNSHIP 37 SOUTH, RANGE 1 WEST OF THE WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON; THENCE ALONG THE NORTH LINE OF SAID SECTION, SOUTH 89°54'27" EAST, 769.25 FEET; THENCE SOUTH 00°05'33" WEST, 25.00 FEET TO THE SOUTH RIGHT OF WAY LINE OF LONE PINE ROAD, THE INITIAL POINT; THENCE CONTINUING SOUTH 00'05'33" WEST, 75 FEET; THENCE PARALLEL WITH SAID NORTH SECTION LINE, NORTH 89°54'27" WEST, 8.92 FEET; THENCE SOUTH 00°05'33" WEST. 140.00 FEET; THENCE NORTH 89'55'06" WEST, 112.38 FEET TO THE EASTERLY RIGHT OF WAY LINE OF VALLEY VIEW DRIVE; THENCE ALONG SAID RIGHT OF WAY LINE. 46.95 FEET ALONG THE ARC OF 75.00 FOOT RADIUS CURVE TO THE RIGHT (THE LONG CHORD OF WHICH BEARS NORTH 18'04'27" WEST, 46.18 FEET); THENCE NORTH 00°05'34" WEST, 44.49 FEET; THENCE 35.69 FEET ALONG THE ARC OF A 75.00 FOOT RADIUS CURVE TO THE RIGHT (THE LONG CHORD OF WHICH BEARS NORTH 13'32'22" EAST, 35.35 FEET); THENCE 59.48 FEET ALONG THE ARC OF A 125.00 FOOT RADIUS CURVE TO THE LEFT (THE LONG CHORD OF WHICH BEARS NORTH 13'32'23" EAST, 58.92 FEET); THENCE NORTH 00°05'34" WEST, 21.91 FEET; THENCE 20.50 FEET ALONG THE ARC OF A 13.00 FOOT RADIUS CURVE TO THE RIGHT (THE LONG CHORD OF WHICH BEARS NORTH 44°54'52" EAST, 18.44 FEET TO SAID SOUTH RIGHT OF WAY LINE OF LONE PINE ROAD; THENCE ALONG SAID LINE, SOUTH 89'54'27" EAST, 100.99 FEET TO THE INITIAL POINT.


