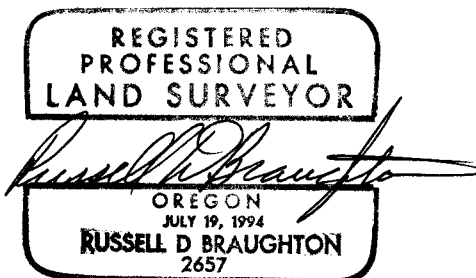
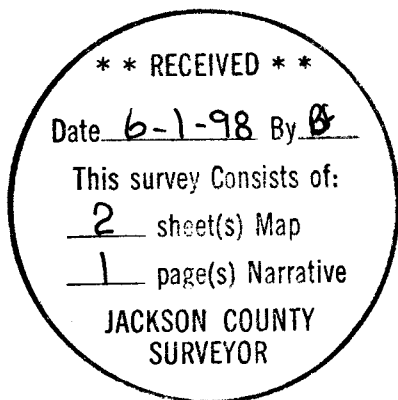
**PURPOSE:** MAP OF SURVEY: To locate and monument the

Number 3319, computed the boundaries of the tract  
as shown. The boundaries of Tax Lot 216 were then  
monumented as shown. Monuments set on this survey  
consist of 5/8" x 30" steel pins with red plastic

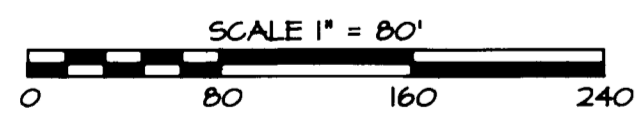
DETAIL B
