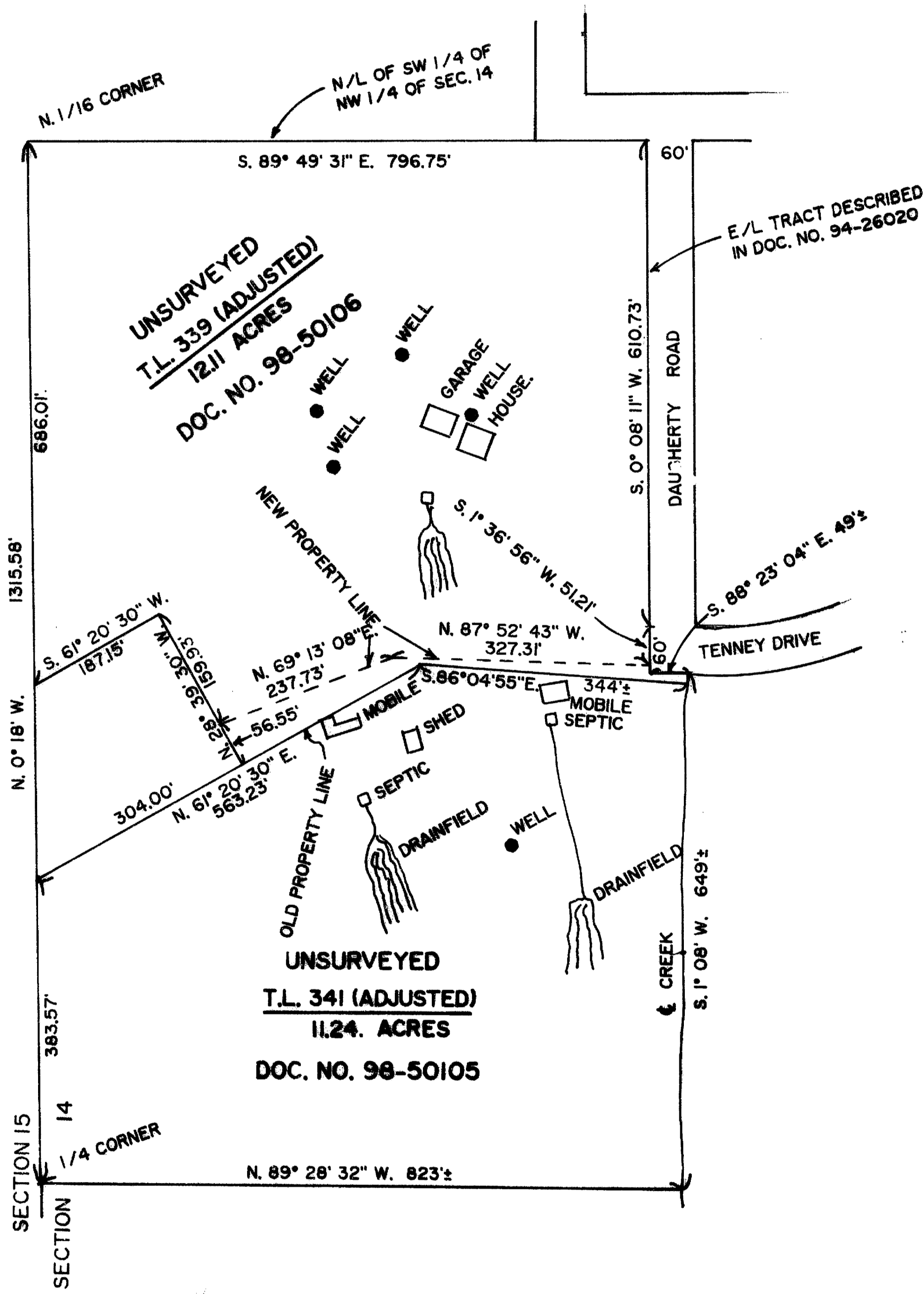

Willamette Meridian, Jackson County, Oregon.

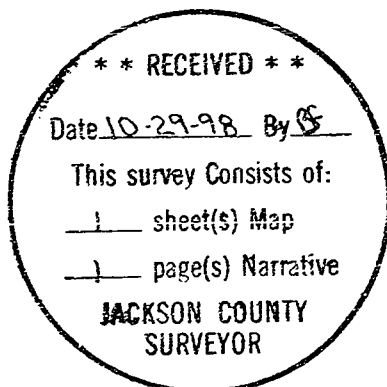
PROCEDURE: Utilizing information information taken from
