

AT THE NORTH ONE-SIXTEENTH CORNER COMMON TO SECTION 26 AND SECTION 27 I SET A 2-INCH DIAMETER ALUMINUM CAP.

FROM WHICH:

AN 18.5 INCH DIAMETER MADRONA BEARS S78°58'W, 13.5 FEET, MARKED N1/16S27 IN UPPER FACE, BT IN LOWER FACE. A 7 INCH DIAMETER DOUGLAS FIR BEARS S47°51'E, 5.8 FEET, MARKED N1/16S26 IN UPPER FACE, BT IN LOWER FACE.

AT THE NORTHWEST ONE-SIXTEENTH CORNER OF SECTION 26 I SET A 2 INCH DIAMETER ALUMINUM CAP.

FROM WHICH:

AN 11 INCH DIAMETER DOUGLAS FIR BEARS N54°30'E, 32.9 FEET, MARKED NW1/16S26 IN UPPER FACE, BT IN LOWER FACE.
A 12.5 INCH DIAMETER DOUGLAS FIR BEARS S18°01'E, 40.5 FEET, MARKED NW1/16S26 IN UPPER FACE; BT IN LOWER FACE.

AT THE NORTHWEST CORNER OF PARCEL DESCRIBED IN INSTRUMENT NUMBR 94-42228 I SET A 2 INCH DIAMETER ALUMINUM CAP.

FROM WHICH:

AN 8.5 INCH DIAMETER MADRONA BEARS \$71°30°W, 116.04 FEET, MARKED BT IN ONE FACE.

A 7 INCH DIAMETER OAK BEARS N28°06'E, 35.1 FEET, MARKED BT IN ONE FACE.

AT THE SOUTHWEST CORNER OF PARCEL DESCRIBED IN INSTRUMENT NUMBER 94-42228 I SET A 2 INCH DIAMETER ALUMINUM CAP.

AT THE SOUTHEAST CORNER OF PARCEL DESCRIBED IN INSTRUMENT NUMBER 94-42228 I SET A 2 INCH DIAMETER ALUMINUM CAP.

AN 8 INCH DIAMETER MAPLE BEARS S20°29'W, 23.1 FEET, MARKED BT IN ONE FACE.



I MARK A NEW TREE AT THE ONE-QUARTER CORNER COMMON TO SECTION 22 AND SECTION 23. AT THE CORNER LOCATION I FOUND A 3 INCH DIAMETER BLM BRASS CAP.

PURPOSE:

TO SURVEY, MARK, AND POST CERTAIN BOISE CASCADE PROPERTY LINES IN SECTIONS 22, 27, AND 26 AS SHOWN ON THE

MAP OF SURVEY TO ACCOMPANY THIS NARRATIVE.

PROCEDURE:

A SEARCH OF RECORDS REVEALED THAT THE CORNERS NEEDED FOR CONTROL OF THIS SURVEY HAD BEEN RE-ESTABLISHED FROM ORIGINAL EVIDENCE OR PROPORTIONATE MEASUREMENT. THE ONE-QUARTER CORNER COMMON TO SECTION 22 AND SECTION 23 HAD BEEN RE-ESTABLISHED BY L.E. AGER ON SURVEY NUMBER 3375. THE BUREAU OF LAND MANAGEMENT (BLM) SURVEYED THE LINE COMMON TO SECTION 22 AND SECTION 23 AND FOUND THE MONUMENT SET ON SURVEY NUMBER 3375 FOR THE CORNER COMMON TO SECTIONS 22 AND 23 TO BE OUT OF POSITION. AT THIS TIME THE BLM SET A MONUMENT FOR THE PROPORTION POSITION FOR THE ONE-QUARTER CORNER COMMON TO SECTIONS 22 AND 23. THE BLM POSITION FOR THE CORNER COMMON TO SECTIONS 22 AND 23 WAS ACCEPTED AS THE BEST POSSIBLE EVIDENCE FOR THIS CORNER.

TO MARK THE BOUNDARY OF THAT PARCEL OF LAND DESCRIBED IN INSTRUMENT NUMBER 98-42228 THE DISTANCES WERE HELD BEGINNING AT THE EAST ONE-QUARTER CORNER OF SECTION 22. THE NORTH LINE OF SAID PARCEL WAS RUN ALONG THE NORTH LINE OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 22. THE SOUTH LINE OF SAID PARCEL WAS RUN PARALELL TO THE NORTH LINE OF SAID PARCEL. THE EAST LINE OF SAID PARCEL WAS RUN ALONG THE EAST LINE OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 22. THE WEST LINE OF SAID PARCEL WAS RUN PARALELL TO THE EAST LINE OF SAID PARCEL.

SURVEY NUMBER 11020 WAS USED TO CALCULATE THE SUBDIVISON OF THE NORTHWEST QUARTER OF SECTION 26.A SURVEY WAS RUN TYING TO THE MONUMENTS NEEDED FOR CONTROL. THEN THE MONUMENTS WERE SET AND LINES WERE MARKED AND POSTED AS SHOWN ON THE PLAT TO ACCOMPANY THIS NARRATIVE.

CORNERS SET THIS SURVEY:

ALL MEASUREMENTS TO BEARING TREES ARE TO THE CENTER OF TREE AT BASE UNLESS OTHERWISE STATED. ALL BEARING TREES HAVE A BRASS WASHER MARKED PLS 1086 NAILED TO LOWER FACE.
