
MAP OF SURVEY LOCATED IN THE S.W. 1/4 OF S6

PURPOSE:

BOUNDARY LINE ADJUSTMENT: PLANNING DEPARTMENT FILE NUMBER 98-4PLA. TO ADJUST THE LOT LINES BETWEEN TAX LOTS 700 & 801. TO SHOW THE ADJUSTMENT LINES FOR SAID LOT LINE ADJUSTMENT (98-4PLA) FOR JACKSON COUNTY PLANNING DEPARTMENT. TO MARK THE LINES AND SET MONUMENTS AS SHOWN ON THE MAP TO ACCOMPANY THIS

NARRATIVE.

PROCEDURE

A SEARCH OF RECORDS REVEALED THAT SAID SOUTHWEST QUARTER OF SECTION 6 HAD BEEN SUBDIVIDED ON SURVEY NUMBER 10624, AND THAT SAID NORTHWEST QUARTER OF SECTION 7 HAD BEEN SUBDIVIDED ON SURVEY NUMBER 13994. A CLOSED TRAVERSE SURVEY WAS RUN TYING TO THE NORTH ONE-QUARTER CORNER AND THE CENTERNORTH ONE-SIXTEENTH CORNER OF SECTION 7 FOR CONTROL OF THIS SURVEY. THE NEW LOT LINES WERE THEN CALCULATED AND RAN. THE NEW LOT LINES WERE THEN MARKED AND THE MONUMENTS SET AS SHOWN ON THE MAP TO ACCOMPANY THIS NARRATIVE.

THE RAILROAD RIGHT OF WAY WAS NOT SURVEYED ON THIS SURVEY. THE POSITION OF SAID RAILROAD RIGHT OF WAY THROUGH THE SOUTHWEST QUARTER OF SECTION 6 AND THE NORTHWEST QUARTER OF SECTION 7 WAS DRAWN IN FROM RAILROAD RIGHT OF WAY MAPS ONLY. NO ATTEMPT WAS MADE TO SHOW OWNERSHIP OF LAND INCLUDED WITHIN THE BOUNDARIES OF THE RAILROAD RIGHT OF WAY. THE RAILROAD RIGHT OF WAY WAS INCLUDED ONLY TO SHOW ACREAGE FOR JACKSON COUNTY PLANNING DEPARTMENT REASONS.
