Surveyor's Certificate:

I, Herbert A. Farber, a duly registered Professional Land Surveyor of the State of Oregon, do hereby certify that I have correctly surveyed and marked with proper monuments, as provided by law, the tract of land hereon shown, this plat being a correct representation of the same, and the following is an accurate description of the boundary lines:

Lot 4, Block 2, ROGUE VALLEY INDUSTRIAL PARK - UNIT NO. 1, in the City of Medford, County of Jackson, State of Oregon, more particularly bounded and described as follows:

Beginning at a 5/8 inch iron pin monumenting the southeast corner of Lot 4, Block 2, Rogue Valley Industrial Park, Unit No. 1, recorded in Volume 12, Page 16 of the Plat Records of Jackson County, Oregon, from which a brass cap monumenting the southeast corner of Section 18, Township 37 South, Range 1 West, Willamette Meridian, bears North 19°10'21" West - 916.94 feet; thence, following the southerly line of said Lot 4, common with the northerly right of way for Knutson Avenue, North 89'48'33" West - 214.00 feet (record North 89'48'00" West); thence 78.54 feet along the arc of a 50 foot radius curve to the right, having a delta angle of 90°00'00" (chord bearing North 44°48'31" West — 70.71 feet) to a concrete nail monument on the east right of way for Biddle Road, common with the westerly line of said Lot 4; thence, following said right of way for Biddle Road, North 0°11'27" East — 73.46 feet (record North 0°12'00" East — 73.33 feet), to a concrete nail monumenting the northwest corner of said Lot 4; thence leaving said right of way, South 89°48'33" East — 264.00 feet (record South 89°48'00" East), to a 5/8" iron pin monumenting the northeast corner of said Lot 4; thence, South 0°11'27" West — 123.46 feet (record South 0°12'00" West - 123.33 feet), to the POINT OF BEGINNING.

To survey and monument the land partition as approved by the City of Medford Planning Department File No. LDP-98-158, dated January 19, 1999.

Utilizing Global Positioning Satellite recievers, a Nikon total station with a Sokkia SDR-33 data collector, I tie the recovered monuments and monument the Partition corners as shown hereon. An existing fenceline along the northerly boundary of Parcels 1 & 2 rendered it impractical to monument the corners along said boundary. Witness corner monuments were placed as shown hereon.
