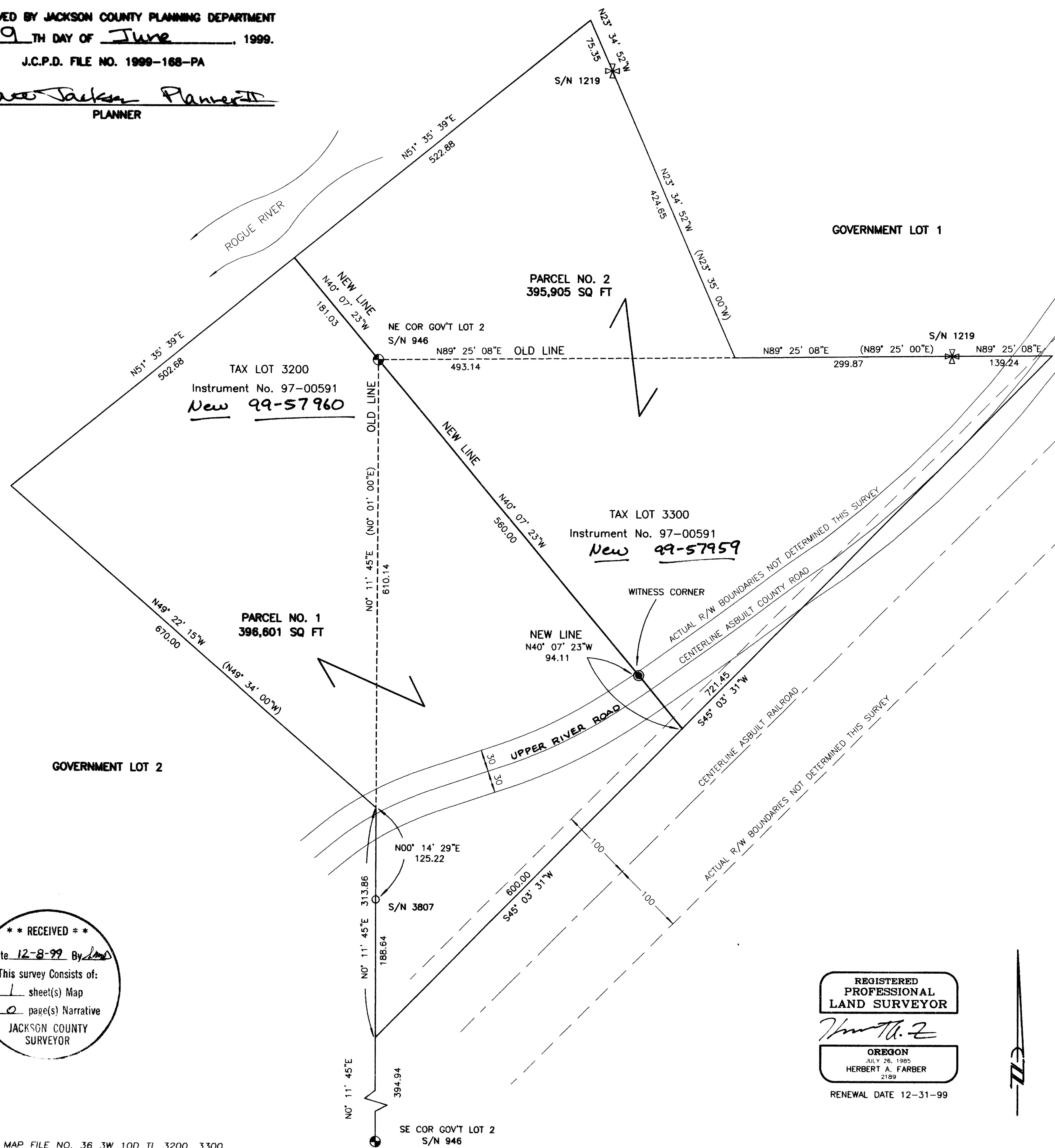

PURPOSE: TO SURVEY AND MONUMENT THAT PROPERTY LINE ADJUSTMENT AS APPROVED BY JACKSON COUNTY PLANNING DEPARTMENT

PROCEDURE: UTILIZING GLOBAL POSITIONING SYSTEM RECEIVERS AND A NIKON TOTAL STATION WITH A SOKKIA SDR 33 DATA COLLECTOR I TIE THE NORTHEAST AND SOUTHEAST CORNERS OF GOVERNMENT LOT 2 AND A 5/8 INCH IRON MONUMENT, AS SHOWN ON FILED SURVEY NO. 3807, ALONG WITH TWO 1/2 INCH SQUARE IRON PINS, AS SHOWN ON FILED SURVEY NO. 1219. HOLDING MONUMENTS AS TIED, I COMPUTE THE PROPERTY BOUNDARIES OF THE PARCEL AS DESCRIBED IN INSTRUMENT NO. 97-00591 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON AND ESTABLISH THE CORNERS AS SHOWN HEREON.
