

BASIS OF BEARINGS:

The Basis of Bearings for this survey is the line between found centerline monuments on Morton Street as North 00°02'24" West as shown on the plat of Park Estate, Phase I.

PROCEDURE:

The survey proceeded by locating existing monuments shown on the plat of Park Estates, Phase 1. Found centerline monuments were held for the location of Morton Street and the easterly line of Morton Street was established at a record right angle distance of 23.5 feet from the centerline. Found undisturbed original monuments along the northerly and southerly lines of Lot 12 were held for the position of the northerly and southerly lines respectively. The NW corner and SW corner of Lot 12 was established at the intersection of said southerly and northerly lines with the easterly line of Morton Street and courses to existing monuments were noted. The easterly line of Lot 12, being the exterior line of the subdivision was established parallel with and record 90.00 feet right angle distance from the easterly line of Morton Street. The NE corner and SE corner of Lot 12 were established at the intersection of the easterly line of Lot 12 with the previously established southerly and northerly lines. A 5/8" iron pin with plastic cap stamped, "ALSPACH PLS 2653" was set at the NE corner while a course to an existing monument near the SE corner was noted. The relationship with adjacent surveys, most notably The Pines Subdivision and FS 11733, were noted.


