AFFIDAVIT OF MONUMENTATION

DEFERRED MONUMENTS

KNOW ALL MEN BY THESE PRESENTS, that I, Herbert A. Farber, a duly Registered Professional Land Surveyor of the State of Oregon, do hereby affirm that I have established with proper monuments as required by law those lot corner monuments shown as deferred monument corners on the Official Plat of Shelterwood, as recorded in Volume 24 of Plats on Page 43 of the Plat Records of Jackson County, Oregon. All of the monuments shown as "Deferred Monument" have been established as shown on said plat excepting the following:

Northwest corner of lot 13 now referenced with a 5/8 by 30-inch iron pin with 1 1/2-inch aluminum cap marked "FARBER PLS 2189 WC", brs. S0°04'44"E 0.50' from said northwest corner

5/8 inch iron pin marking the northwest corner of lot 2 replaced with a tack and 1/2 inch brass washer marked "LS 2189".

5/8 inch iron pin marking the easterly point of curve return lot 22 replaced with a tack and 1/2 inch brass washer marked "LS 2189".

5/8 inch iron pin marking the westerly point of curve return lot 21 replaced with a tack and 1/2 inch brass washer marked "LS 2189".

5/8 inch iron pin marking the northerly point of curve return lot 23 replaced with a tack and 1/2 inch brass washer marked "LS 2189".

The southwest corner of lot 21 and the northwest corner of lot 22 now referenced with 5/8-inch iron pins with 1 1/2-inch aluminum cap marked "FARBER PLS 2189 WC", which brs. S89°56'05" 0.25' from said lot corners.
