NOTE

Specific covenants and conditions required by the City of Phoenix, per recorded Instruments No. 98—29179 and No. 98—29180, Jackson County Deed Records as follows;

"The property owner shall dedicate a 50 foot wide portion of an 80 foot wide right of way along the East property line to the future intersection of the Freshwater Street extension that will exist when development of the adjacent residential project takes place. From that intersection, the property owner shall dedicate a 30 foot wide portion of a 60 foot wide right of way that shall extend South to intersect with Pear Tree Lane. The property owner is responsible for the "fair share" cost of that creation of this new "South Phoenix Road" (the right of way would be split with the adjacent property to the East). It is realized that this new roadway will benefit other properties and businesses in the area. Therefore, the definition of "fair share" shall be determined at the time a funding mechanism is established for construction of this roadway. The most likely funding mechanism will be through the formation of an L.I.D. The property owner shall enter into a Deferred Improvement Agreement with the City to cover any deferred improvements that are not constructed at the time of development. The timing of development of this roadway shall be at the sole discretion of the City and will be tied to the traffic needs generated by new development in the interchange area. The property owner may be required to fund the full amount of some portion of this roadway on an interim basis subject to a partial reimbursement under a Reimbursement Agreement.

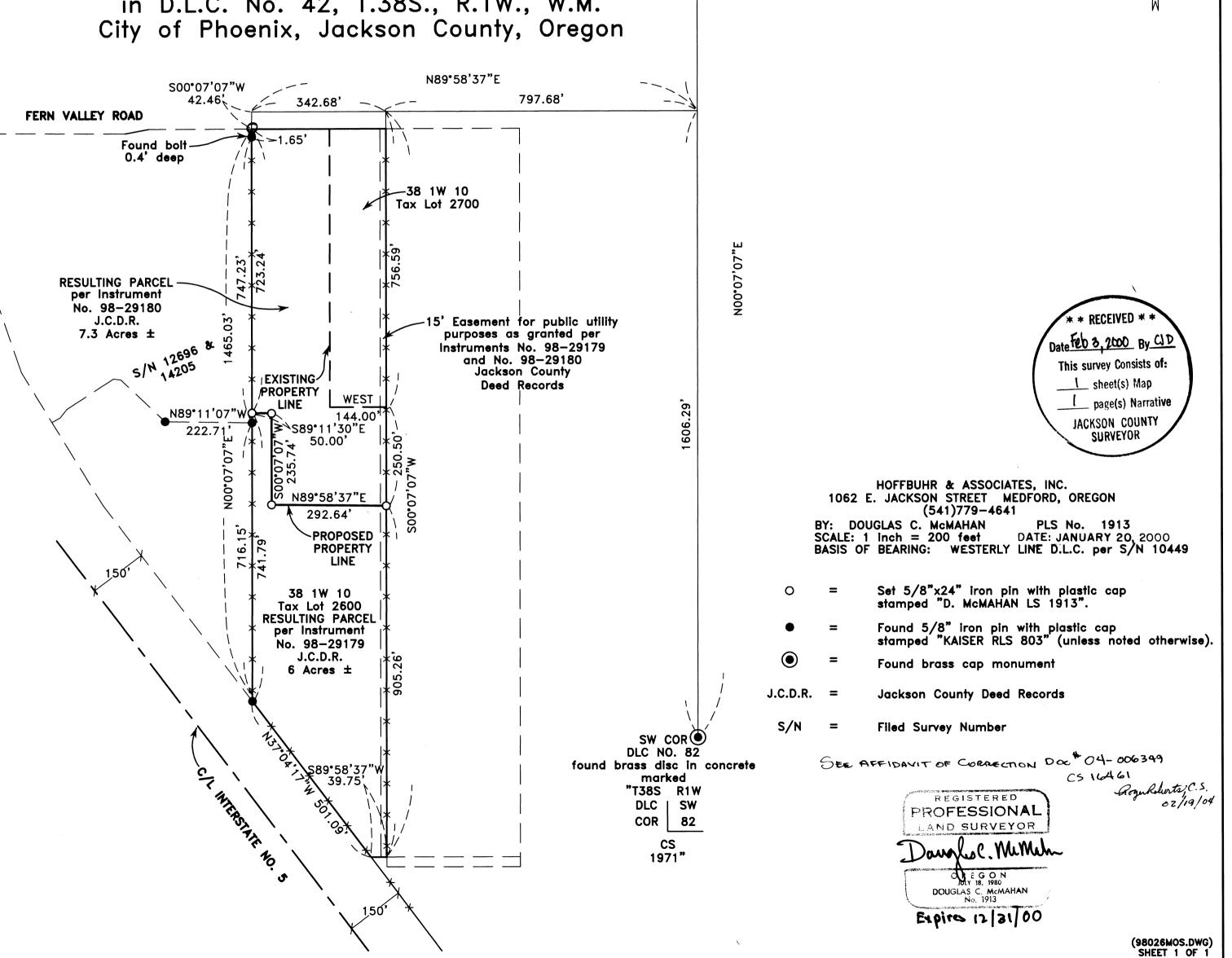
The property owner shall also dedicate a 60 foot right of way for a future East/West street that will connect the Petro Shopping Center's truck stop to the future South Phoenix Road (an extension of Freshwater Street). The exact location of this street shall be determined by the City of Phoenix. The property owner shall enter into a Deferred Improvement Agreement that will allow for the deferral of construction of this street until either development takes place or when the City is able to form an L.I.D. or other funding mechanism to cover the cost of the street. The street section shall conform with the attached Exhibit "D" unless modified by the City."

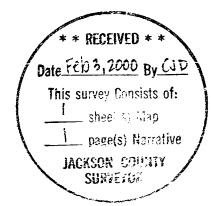
