AFFIDAVIT OF MONUMENTATION FOR DEFERRED MONUMENTS

KNOW ALL MEN BY THESE PRESENTS, that I, Darrell L. Huck, a duly Registered Professional Land Surveyor in the State of Oregon, do hereby affirm that I have established, with proper monuments as required by law, those monuments as shown as deferred on the Official Plat of WEST BELLVIEW SUBDIVISION (A Planned Community) as recorded in Volume 21, Page 17 of Plats in Jackson County, Oregon.

All of the monuments shown as "Deferred Monument" have been established with a 5/8 inch by 24 inch iron rebar with plastic cap marked "D. HUCK LS 2023" EXCEPT THE FOLLOWING:

- 1. The Northeast corner of Lot 12 is marked with a lead and tack with brass washer marked "LS 2023" in concrete sidewalk.
2. The Southwest corner of Lot 12 falls in a wooden porch, therefore the Northeast corner of Lot 13 will also serve as a 4.00 foot witness monument to the Southwest corner of Lot 12.
3. The Southeast corner of Lot 12 falls in a porch, therefore the Northeast corner of Lot 17 will also serve as a 5.81 foot witness monument to the Southeast corner of Lot 16.

This affidavit is to comply with Chapter 92.070 of the Revised Statutes of the State of Oregon.
