**AFFIDAVIT OF MONUMENTATION
FOR
DEFERRED MONUMENTS**

KNOW ALL MEN BY THESE PRESENTS, that I, Darrell L. Huck, a duly Registered Professional Land Surveyor in the State of Oregon, do hereby affirm that I have established, with proper monuments as required by law, those monuments as shown as deferred on the Official Plat of TERRACE PINES SUBDIVISION as recorded in Volume 17, Page 30 of Plats in Jackson County, Oregon.

All of the monuments shown as "Deferred Monument" have been established with a 5/8 inch by 24 inch iron rebar with plastic cap marked "D. HUCK LS 2023" *EXCEPT THE FOLLOWING:*

1. A lead plug with tack and brass washer stamped "L.S. 2023" was set in concrete sidewalk at:
 - (a) the point of reverse curve on the southwesterly boundary of Lot 3;
 - (b) the point of reverse curve on the southwesterly boundary of Lot 4;
 - (c) the most southerly corner of Lot 4;
2. A 2" brass disc marked "L.S. 2023" was set on a 1" iron pipe in monument case at the centerline points of Terrace Street.
3. Due to rock wall construction a 5/8" x 24" iron pin with plastic cap marked "D.Huck L.S. 2023" was set as a 5.00 foot witness monument on the line common to Lots 5 and 6 to reference the southwest corner of Lot 5;
AND ALSO, a 5.00 foot witness monument on the line common to Lots 6 and 7 to reference the most northerly corner of Lot 7.

This affidavit is to comply with Chapter 92.070 of the Revised Statutes of the State of Oregon.
