SURVEYOR'S CERTIFICATE


I, Richard G. Templin, a duly registered surveyor of the State of Oregon, do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law the tract of land hereon shown and the plat is a correct representation of the same, and the following is an accurate description of the boundary lines:

Parcel No. Three (3) of Partition Plat recorded January 15, 1997, as Partition Plat No. P-2-1997 of "Record of Partition Plats" in Jackson County, Oregon, and filed as Survey No. 15247 in the Office of the County Surveyor.

NARRATIVE

PURPOSE OF SURVEY: To divide Parcel 3 of Partition Plat number P-02-1997 (SN 15247) into two seperate Parcels.

PROCEDURE: I tied the Southeast corner of DLC number 59 and the Northwest corner of DLC 57 along with monuments set on Alder Creek Subdivision. I did a dependent resurvey of Partition Plat number P-02-1997, as most of the monuments were destroyed with landscaping and improvements of the existing shopping center. The original monuments on the Westerly boundary fall in a concrete fence, so I set reference monuments as shown. I replace the remaining monuments of the outside boundary of Parcel 3 of Partition Plat number P-02-1997 at their computed positions. The newly created Partition line was monumented as shown.
