I, Herbert A. Farber, a duly registered Professional Land Surveyor of the State of Oregon, do hereby certify that I have correctly surveyed and marked with proper monuments, as provided by law, the tract of land hereon shown, this plat being a correct representation of the same, and the following is an accurate description of the boundary lines:

Commencing at a brass cap monumenting the Southwest corner of Donation Land Claim No. 58, located in the Southeast Quarter of Section 11, Township 37 South, Range 2 West of the Willamette Meridian in Jackson County, Oregon; thence North 00°04'44" West, along the west line of said Donation Land Claim, 780.02 feet; thence North 89°55'16" East, leaving said west line, 30.00 feet to a 5/8 inch iron pin, on the east line of Bursell Road, marking the northwest corner of that tract described in Document No. 95-37013, Official Records of said County, said pin also being the northwest corner of that parcel described in Document No. 97-46941, said Official Records, said pin being the POINT OF BEGINNING and the INITIAL POINT of this Partition; thence South 89°56'05" East, along the north line of said Tract, said north line also being the north line of said Parcel, 220.00 feet to a 5/8 inch iron pin marking the northeast corner of said Parcel, said northeast corner also being the northwest corner of Lot 12 of Shelterwood Subdivision as recorded in Volume 24, Page 43 of the Plat Records of said County; thence, leaving said north line of said Tract, South 00°04'17" East, along the east line of said Parcel, said east line also being the west line of said Lot 12, 83.00 feet, to a 5/8 inch iron pin on the northerly right-of -way of Greenleaf Lane marking the southeast corner of said Parcel, said southeast corner also being the southwest corner of said Lot 12; thence North 89°56'05" West, along said northerly right-ofway, said northerly right-of-way also being the south line of said Parcel, 219.99 feet to a 5/8 inch iron pin on the east line of Bursell Road, said pin being the southwest corner of said Parcel; thence, leaving said northerly right-of-way, North 00°04'44" West, along said east line, said east line also being the west line of said Parcel, 83.00 feet to the Initial POINT OF BEGINNING.
