 TO COMPLY WITH O.R.S. 209.250**

PURPOSE: TO SURVEY AND MONUMENT THE LOT CORNERS AS SHOWN HERON, AS PER INSTRUMENT 97-24352.

PROCEDURE: UTILIZING EXISTING CONTROL ESTABLISHED DURING PREVIOUS SURVEYS, PLUS ADDITIONAL CONTROL PERFORMED AS NEEDED, I ESTABLISHED THE LOT LINES AND MONUMENTED THE LOT CORNERS AS SHOWN. THE SOUTH R/W OF HIGHWAY 238 WAS HELD, AS PER S.N 9080. RECORD ANGLE WAS COMPUTED FOR THE EAST BOUNDARY, AND RECORD DISTANCE FROM FROM THE R/W LINE WAS USED ALONG WITH RECORD ANGLE PARALLEL WITH SAID R/W LINE TO ESTABLISH THE NORTH LINE OF TAX LOT 700.
