

Surveyor's Certificate:

I, Herbert A. Farber, a duly registered Professional Land Surveyor of the State of Oregon, do hereby certify that I have correctly surveyed and marked with proper monuments, as provided by law, the tract of land hereon shown, this plat being a correct representation of the same, and the following is an accurate description of the boundary lines:

BEGINNING at a 5/8 inch iron pin marking the northeasterly corner of Lot 9 of New Haven Estates, Phase I as recorded in Volume 24, Page 39 of the Plat Records of Jackson County, Oregon, said pin being on the southwesterly boundary of that tract of land described in Instrument No. 98-04412 of the Official Records of said County, said pin also being the INITIAL POINT of this partition; thence South 61°02'53" East, along said southwesterly boundary, 18.31 feet to a 5/8 inch iron pin on the westerly line of Hamrick Road as described in Instrument No. 01-27999 of said Official Records; thence North 37°20'25" East, along said westerly line, 212.08 feet to a point, on the northeasterly boundary of said tract, that bears South 60°39'10" East 0.36 feet from a 5/8 inch iron pin; thence, leaving said westerly line, North 60°39'10" West, along said northeasterly boundary, to said 5/8 inch iron pin; thence, continuing along said north easterly boundary, North 60°39'10" West 210.51 feet to a 5/8 inch iron pin marking the most northerly corner of said tract; thence South 34°51'49" West, along the northwesterly boundary of said tract, 212.40 feet to a 5/8 inch iron pin marking the most westerly corner of said tract, said pin also being the most southerly corner of Lot 12 of said Phase I; thence south 61°02'53" East, along said southwesterly boundary, 183.50 feet to the initial POINT OF BEGINNING.
