
MAP OF SURVEY PROPERTY LINE ADJUSTMENT

NARRATIVE TO COMPLY WITH_O.R.S. 209.250

Purpose: Pursuant to Clients Instructions, perform a field survey, prepare and process a Property Line Adjustment application with the City of Medford, Oregon, monument the resultant boundary corners and file a Map of Survey with Jackson County, Oregon.

Procedure: Utilizing a Nikon DTM-520 Total Station and a Ranger 200-R Data Collector with TDS software, all found monuments, as depicted hereon, were tied in a closed loop traverse.

Based on said traverse and ties, Survey Number 16369, record as HERRINGTON HEIGHTS SUBDIVISION, UNIT 2, on file at the Jackson County Surveyor's Office, Document Numbered 02-34954 of the Official Records of Jackson County, Oregon and the approved Property Line Adjustment application by the City of Medford, the resultant boundaries were monumented as depicted hereon.

LEGEND

- Indicates a set 5/8-inch iron pin by 30 inches long, with yellow plastic cap marked "NEATHAMER LS 2675", set flush with the surface, or as noted hereon. Monuments now armouse.
- Indicates a found 5/8-inch iron pin with a yellow plastic cap stamped: "D. MCMAHAN LS 1913", top set flush with the surface or as noted. Refer to SN 16369. Unless otherwise noted hereon.
- Indicates a computed position.
- SN Indicates a survey filed number in the office of the Jackson County Surveyor.
- Doc. No. Indicates a document number pursuant to the Official Records of Jackson County, Oregon.
- Vol. Pg. Indicates a document number pursuant to the Deed Records of Jackson County, Oregon.
 - () Indicates Record information, refer to SN 16369, as filed in the office of the Jackson County Surveyor.

Shaded area indicates a perpetual easement for public utilities, including but not limited to storm drainage, sanitary sewer, water, gas, electric, telephone, and cable television, as granted by instrument recorded February 6, 1998 as Number 98-04490 of the Official records of Jackson County, Oregon.

Lots Numbered 31 and 32 shall not have vehicular access along Foothill Road frontage.
