**AFFIDAVIT OF MONUMENTATION**

KNOW ALL MEN BY THESE PRESENTS, that I, Douglas C. McMahan, a duly Registered Professional Land Surveyor of the State of Oregon, do hereby affirm that I have established with proper monuments as required by law those monuments shown as deferred on the Official Plat of EDGEWOOD ESTATES SUBDIVISION, as recorded in Volume 18, Page 40 of Plats in Jackson County, Oregon. The deferred street center monuments consist of a brass disc stamped "LS 1913" set flush in concrete, including the Point of Intersection of Edgewood Drive centerline which bears North 39°02'17" East 4.75 feet from the set 5/8 inch x 30 inch rebar with 2 1/2 inch metal cap stamped "LS 1913" marking centerline intersection of Edgewood Drive and the centerline to center of cul-de-sac. The deferred lot corners are 5/8 inch x 24 inch rebar with yellow plastic caps marked "D.MCMAHAN LS 1913."
