

AFFIDAVIT OF MONUMENTATION FOR DEFERRED MONUMENTS

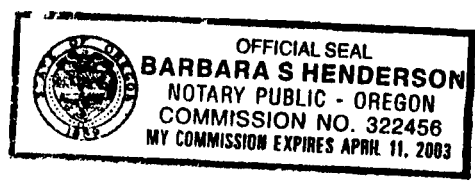
