SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE:

TO SURVEY AND MONUMENT THE PROPERTY LINE ADJUSTMENT SHOWN HEREON AND APPROVED PER JACKSON COUNTY PLANNING FILE NUMBER 2003-24-PLA. AND TO ESTABLISH MISSING LOT CORNER FOR TAX LOT 500.

PROCEDURE:

USING CONTROL ESTABLISHED IN THIS AND PREVIOUS SURVEYS I TIED THE MONUMENTS SHOWN HEREON. UPON REVIEW OF S/N 8311 AND 2337 AND INSTRUMENT NO. 98-29566 SEVERAL DISCRÉPANCIES WERE FOUND BETWEEN SAID RECORDS. SAID INSTRUMENT CONTAINED A SCRIVENERS ERROR WHILE DESCRIBING TAX LOT 500 SHOWN HEREON, I THEREFORE USED INSTRUMENT NO. 76-13188 TO DEFINE SAID TAX LOT 500. IT SHOULD BE NOTED THAT INSTRUMENT NO. 76-13188 HAS A RELATIVE ERROR OF CLOSURE OF 1 IN 173, WHICH TRANSLATES INTO A LINIER DISTANCE OF 16.89 FEET. DISTANCES IN THE EAST WEST DIRECTION ON S/N 2337 APPEAR TO BE SHORT BY APPROXIMATELY 15 FEET. THIS ERROR WAS CONFIRMED BY S/N

THE MONUMENTS MARKING THE BOUNDARY OF THE PARCEL LABELED TAX LOT 108, HEREON, WERE FOUND TO AGREE WITH DEED AND SURVEY RECORD AND WERE HELD AS THE LOT CORNERS. THE WEST LINE OF THIS PARCEL WAS HELD TO BE THE NORTH-SOUTH CENTER LINE OF SECTION 14. TOWNSHIP 35 SOUTH, RANGE 2 WEST, OF THE WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON.

THE NORTHWEST CORNER OF TAX LOT 108 WAS HELD TO BE THE NORTHEAST CORNER OF TAX 500. THE NORTH LINE OF THE LOT WAS THEN RUN THROUGH THE FOUND PIN TO THE RIGHT-OF-WAY LINE ESTABLISHED BETWEEN THE SHOWN MONUMENTS. I THEN TRAVELED DOWN THE RIGHT-OF-WAY LINE RECORD DISTANCE PER INST.NO. 76-13188. I THEN HELD THE RECORD BEARING PER INSTRUMENT. NO. 76-13188 FOR THE CENTER LINE OF THE VACATED ROAD AND TRAVELED TO THE SAID NORTH-SOUTH CENTER OF SECTION LINE. I THEN CLOSED TO THE NORTHEAST CORNER ALONG SAID CENTER OF SECTION LINE.

THIS OFFICE, USING THE EVIDENCE MENTIONED ABOVE, DERIVED THE SOLUTION SHOWN HEREON. AFTER TAKING INTO ACCOUNT THE DISCREPANCIES MENTIONED ABOVE THIS SOLUTION IS FELT TO REFLECT THE INTENT OF THE DEED.
