AFFIDAVIT OF CORRECTION pursuant to O.R.S. 209.225

I, Darrell L. Huck, a Registered Professional Land Surveyor of the State of Oregon, No. 2023, do hereby state that it has been discovered that two monuments on Map of Survey done by Douglas C. McMahan and filed as Survey No. 17883 in the Office of the Jackson County Surveyor, were identified incorrectly. Also it should be noted that other monuments had been set within the boundaries of subject property for a proposed subdivision (PEAR BLOSSOM CENTER SUBDIVISION, PHASE 1). Proposed lot corner and proposed right-of-way dedications were monumented. Application for final plat was made to City of Central Point and to the Jackson County Surveyor. However the owner decided to drop the plan for the subdivision. All monuments pertinent to the proposed development except as shown on filed Survey No. 17883 were removed. The monuments removed included monuments identified on filed Survey No. 17759 as monuments No. 102, 103 and 105-110.
