## Survey Narrative to Comply with OR.S. 209.250

SURVEY FOR: Arlene Rousan
3322 Corey Road
Central Point, Or. 97502

BASIS OF BEARING: Filed Survey No. 1152, east-west centerline of Section 28. Shown as N89°59'40"W

LOCATION: Northwest ¼ of Section 28, Township 36 South, Range 1 West, Willamette Meridian, Jackson County, Oregon.

PURPOSE OF SURVEY: To survey the subject parcel and monument the second phase of a property line adjustment. Prepare and file a map of survey.

PROCEDURE: A field control traverse was previously established in the subject area (FS 17859) using a Wild T-1000 total station. Found monuments from Filed Surveys 2949, 1152, 5407 and 16900 were tied to control the Corey Road right of way and to compare measurements. As well, the 1/4 corners and northwest corner of Section 28 were controlled. The northwest 1/4 of said Section 28 was subdivided and the client property boundaries were computed. Originally, the subject quarter-quarter was conveyed out as basically the west 10 acres and the east 30 acres. Subsequently the 30 acres was sold off in strips, the dimensions indicating that the intent was to convey the 30 acres (distance calls were to thousandths) and the total acreage added to a total of 30 acres. By using strictly the called distances in the later descriptions, it would appear there was a gap between tax lot 3500 and 3600. However, research clearly supported the interpretation that the true purpose was to convey out two adjoining parcels by acreage and later scriveners corrupted the original intent by altering the language. By virtue of the fact that the easterly 30 acres was in good faith conveyed out in distinctly measured parcels, it became obvious that the westerly remaining portion was intended to be the westerly 10 acre parcel. The adjusted property line was computed and monuments set. A map of survey was prepared and filed. See Filed survey No. 17859 for details of previous Lot Line Adjustment, county file number (2003-16-PLA).
