PROCEDURE:


Utilizing three Wild dual frequency GPS systems, I conducted a rapid static survey of set monuments as shown on the attached Map of Survey. Jackson County Geodetic Network Points 151, 152A, and 157, as well as H.A.R.N. Point Justice were used to control this survey. Two base lines were measured from each set monument to two control points. Horizontal precision for this survey falls well within the classifications for first order, Class C, standards. Elevations for this survey were calculated differentially, utilizing GEOID 96 from the National Geodetic Survey. The elevations were determined by GPS observation and are not classified.

The following is a list of points set for this survey and their locations:

- #231 Point lies at the Northerly edge of North Phoenix Road, approximately one foot South of the Northerly edge of asphalt at Easterly point of tangency of curve to right as North Phoenix Road leaves Easterly side of Interstate No. 5. 0.6 miles Northerly of intersection of North Phoenix Road and Fern Valley Road.
- #232 Point lies 8 feet Westerly of the Westerly edge of asphalt of Marigold Lane, approximately 225 feet Southerly of driveway to 3265 Marigold Lane. 0.1 miles Northerly of intersection of Marigold Lane and Fern Valley Road.
- #233 Point lies 16.5 feet Southwesterly of Southwesterly rail of the Central Oregon and Pacific Railroad. Southwest fence corner of Carefree Mobile Estates at 3848 South Pacific Highway bears South 82° East.
- #234 Point lies in center of most Southerly East-West road in Medford Mobile Estates at 3555 South Pacific Highway. Point lies on projection of walkway to mobile home space #185.
- #235 Point lies behind chain link gate at Easterly side of Bear Creek Valley Sanitary Authority compound located at 3915 South Pacific Highway. Northerly edge of gate bears South 44° West, a distance of 7.3 feet.
- #236 Point lies 150 feet Southerly of intersection of Fern Valley Road and Luman Road in the City of Phoenix. Point lies 4 feet Northerly of Southerly face of curb of Luman Road.
- #237 Point lies Northwesterly of Phoenix High School Track. Northwest corner of shot put ring bears South 42° East 97.10 feet.

#238 – Point lies 0.6 miles Southerly of intersection of Pear Tree Lane and Fern Valley Road. Point lies 6 feet Northeasterly of I-5 right-of-way fence and 2 feet Southwesterly of Southwesterly edge of gravel of Pear Tree Lane.

#239 – Point lies 285 feet Southerly of intersection of Hilsinger Road and 1st Street in the City of Phoenix. Point lies 3 feet Westerly of Westerly edge of asphalt of Hilsinger Road.

#240 – Point lies 9.5 feet Southwesterly of Southwesterly edge of asphalt of South Pacific Highway. Power Pole 10/32 bears North 34° West 48.5 feet. Southerly of 2 48" CMP bears North 22° West 15 feet.

#241 – Point lies 30 feet Northeasterly of Mile Post 28, Northeasterly edge of Interstate #5. Point lies 9 feet Northeasterly of guard rail.

#242 - Point lies in field Northerly of 2370 Houston Road, 30 feet West of a NS wire fence.

#243 - Point lies Northerly of 4127 Fern Valley Road. Point lies 12.4 feet Easterly of a NS fence line, approximately midway between Fern Valley Road and the Northwest corner of Donation Land Claim No. 82.

#244 – Point lies in Southerly edge of orchard, just Northerly of residence at 4332 Fern Valley Road.


#245 – Point lies at Northerly edge of field behind 1705 Camp Baker Road. Fence corner at Southwest corner of said property bears North 76° West a distance of 50.00 feet.

#246 – Point lies in Southwesterly corner of field, Easterly of barn, behind 4263 Colver Road. Northerly post for large wood gate bears South 72° West, a distance of 21 feet.
