

LOCATION:

Located in Donation Land Claim No. 40, in the southeast 1/4 of Section 5, Township 39 South, Range 1 East, Willamette Base and Meridian, City of Ashland, Jackson County, Oregon.

PURPOSE:

To create and record an Amended Plat of the Wood Creek Condominium by the removal of Unit 1 and a portion of the area held in common ownership from the Wood Creek Condominium in Ashland, Oregon.

BASIS OF BEARINGS:

True meridian at the north-south centerline of Section 5 as derived from the N.O.A.A. survey net on file in the office of the Jackson County Surveyor. Bearings for this survey were based on Filed Survey No. 7767.

PROCEDURE:

As an Amended Plat, much of this map is based on information provided in Filed Survey No. 7767, Wood Creek Condominium. Only one original set monument from the condominium survey was recovered but with the tie to the northwest corner of DLC No. 40, the centerline monument at Coolidge Street, and the Initial Point of Glenview Estates, the original boundary could be retraced; generally holding record bearings. Since the recording of Wood Creek Condominium, there has been a realignment of North Main Street and a dedication of additional right of way along the frontage. Monuments from the right of way survey (Filed Survey No. 15088) were recovered and used to determine stationing and the new centerline location. Building corner locations were verified; where possible the actual foundation walls were located, in other instances the siding thickness was taken into account.
