boundary of the Mayo property, adjacent to the Bear Creek


Orchards, Inc. property.


PROCEDURE:

A preliminary boundary (E.D.M.) survey of the Bear Creek Orchards, Inc. property involving the Official Plat of ROYAL ORCHARD TRACT No. 3 and adjacent lands was performed by Boyden Surveyors between April and November of 1998. No property corners were set, mainly because of the difficulties of accurately locating the lot corners of said plat. However, portions of Payne Road and Suncrest Roads were located from the County 1910 road survey which was under the direction of Frank A. Grisez, County Surveyor, being also the surveyor of ROYAL ORCHARD TRACT No. 3. From this data, monumented the adjusted property boundary as shown, and descriptions prepared. Tied to the Quarter corner common to Sections 13 & 24, as located by the County Surveyor.

The road width of Suncrest Road was determined by the County Road Department, being 20' North from the 1910 road survey line and 15' South (See previous County Road Petition).

Monumented the North boundary of the Mayo tract along an existing fence line, a boundary agreeable to both property owners, and the most-practical considering the difficulty in locating interior lines within Royal Orchard Tract No. 3.
