## SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

### Purpose:

TO SURVEY AND MONUMENT THE BOUNDARIES OF LOT 11 AND LOT 5 OF THE STAGE COACH HILLS SUBDIVISION UNIT NO.3.

### Procedure:

A SEARCH WAS MADE FOR THE ORIGINAL MONUMENTS. THEN USING CONTROL ESTABLISHED IN PREVIOUS SURVEYS IN THE AREA I TIED THE FOUND MONUMENTS AS SHOWN HEREON. TO ESTABLISH THE NORTHERLY RIGHT—OF—WAY OF COACHMAN DRIVE I HELD THE FOUND MONUMENTS (EXCEPT THE MOST SOUTHERLY CORNER OF LOT 5 WHICH WAS FOUND TO BE DISTURBED). TO ESTABLISH THE NORTHWESTERLY LINE OF LOT 5 I HELD THE BEARING OF THE STREET AND TRAVELED NORTHEASTERLY FROM THE FOUND PIN AT THE MOST WESTERLY CORNER OF LOT 6. TO ESTABLISH THE NORTHEASTERLY AND SOUTHWESTERLY LINE OF LOT 5 I TRAVELED PERPENDICULAR TO THE RIGHT—OF—WAY RECORD DISTANCE ALONG SAID RIGHT—OF—WAY.

I HELD THE TWO MONUMENTS FOUND ALONG THE NORTH LINE OF THE FLAG PORTION OF LOT 11. I THEN DID A DISTANCE INTERSECTION BETWEEN THE MOST NORTHERLY CORNER OF LOT 5 AND THE FOUND MONUMENT AT THE EAST END OF THE FLAG USING RECORD DISTANCES TO LOCATE THE REMAINDER OF THE NORTH LINE OF LOT 11. TO LOCATE THE SOUTH LINE OF SAID FLAG I OFFSET THE NORTH LINE 30.00 FEET. TO LOCATE THE WEST END OF THE SAID SOUTH LINE I OFFSET THE LINE LOCATED BETWEEN THE TWO MONUMENT ON THE SOUTHWEST SIDE OF CONESTOGA DRIVE 60.00 FEET TO LOCATE THE NORTH RIGHT—OF—WAY LINE OF CONESTOGA DRIVE. I THEN USED THE RECORD CURVE DATE TO INTERSECT SAID SOUTH LINE. I THEN TRAVELED RECORD DISTANCE DOWN THE SOUTH LINE. THE FOUND MONUMENT WAS OVER 5.00 FEET OUT OF POSITION SO IT WAS NOT HELD. TO COMPLETE THE BOUNDARY OF LOT 11 I TRAVELED ALONG THE NORTHWEST LINE OF LOT 6 RECORD DISTANCE TO LOCATE THE MOST SOUTHERLY CORNER OF LOT 11. DUE TO A CONCRETE FENCE POST NO MONUMENT WAS SET IN THIS LOCATION. I THEN TRAVELED PARALLEL WITH THE SOUTHWEST LINE OF LOT 5 RECORD DISTANCE AND CLOSED TO THE EAST END OF THE SOUTH LINE OF THE FLAG.
