

MAP OF SURVEY PROPERTY LINE ADJUSTMENT

Located within Lots 9, and 10 of FAIRWAYS EDGE, a Planned Community, in the Southeast One-quarter of Section 28, Township 37 South, Range I West, of the Willamette Meridian, City of Medford, Jackson County, Oregon.

NARRATIVE TO COMPLY WITH O.R.S. 209.250

Purpose: Pursuant to Clients instructions, perform a field survey, prepare and process a Property Line Adjustment application with the City of Medford Planning Department, monument the resultant boundary corners and file a Map of Survey with Jackson County, Oregon.

Procedure: Utilizing a Nikon DTM-520 Total Station and a Ranger 200-R Data Collector with TDS software, all found monuments, as depicted hereon, were tied in a closed loop traverse or with redundant ties.

> Based on said traverse and ties, FAIRWAYS EDGE, a planned community, as recorded in Volume 22 of Plats at Page 29 of Records of Jackson County, Oregon, and filed as Survey Number 15507 in the office of the Jackson County Surveyor, of Jackson County Oregon, Documents Numbered 05-31506 and 05-31507 of the Official Records of Jackson County, Oregon, and the Property Line Adjustment approved by the City of Medford Planning Department, the resultant boundaries were monumented as depicted hereon.
