SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE:

TO SURVEY AND MONUMENT THE TRACTS DESCRIBED IN INSTRUMENT No. 00-22313 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON.

CONTROLING CORNERS WERE TIED AND COMPARED TO THE RECORD SURVEY NUMBER 5401. THE TIED LOCATIONS WERE FOUND TO FIT WITHIN ACCEPTABLE LIMITS. THE LOCATION FOR THE WEST ONE—SIXTEENTH CORNER WAS COMPUTED USING THE FOUND POSITIONS OF THE SOUTHWEST CORNER OF SECTION 34 AND THE SOUTH ONE—QUARTER CORNER OF SECTION 34 AND SET AT THE MIDPOINT OF THIS LINE. THE LOCATION FOR THE SOUTHEAST CORNER OF PARCEL 1, TRACT "A" WAS COMPUTED USING THE FOUND LOCATIONS OF THE CENTER—SOUTH ONE SIXTEENTH CORNER AND THE SOUTH ONE—QUARTER CORNER OF SECTION 34 AND SET AT THE MIDPOINT OF THIS LINE. THE LOCATION FOR THE SOUTHWEST CORNER OF PARCEL 1, TRACT "A" WAS COMPUTED USING THE FOUND LOCATION OF THE SOUTHWEST ONE SIXTEENTH CORNER AND THE COMPUTED POSITION OF THE WEST ONE—SIXTEENTH CORNER AND SET 30.00 EASTERLY OF THE MIDPOINT OF THIS LINE ON THE COMPUTED SOUTH BOUNDARY LINE OF PARCEL 1 TRACT "A".
