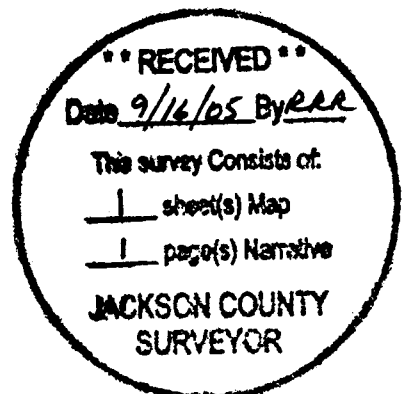
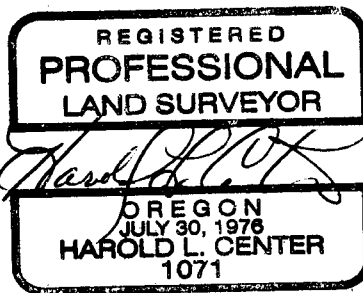
Client was aware of the location of the structures situated on Tax Lot 709 and 703.

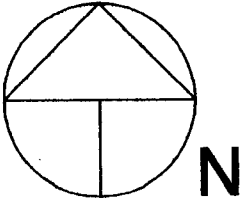

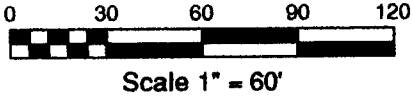
